

Medexus Pharmaceuticals Inc.

**Report of Voting Results for Annual Meeting of Shareholders on September 25, 2025  
(National Instrument 51-102 – Continuous Disclosure Obligations, section 11.3)**

Medexus Pharmaceuticals Inc. (**Company**) held its virtual annual meeting of shareholders on September 25, 2025. Shareholders holding 44.36% of the issued and outstanding common shares of the Company as of the record date of August 12, 2025 were represented in person or by proxy at the meeting.

Voting on all matters at the meeting was conducted by ballot. All matters put to a ballot were passed with the requisite shareholder approval. The detailed results are set out below.

**Election of directors**

(a) Each of the seven nominees in the Company's management information circular dated August 12, 2025 (**Proxy Circular**) was elected to serve until the next annual meeting of shareholders of the Company or until their successor is duly elected or appointed.

(b) The percentages of votes cast for and against the election of each director are set out below.
