On August 15, 2019, the Company exercised 1,500,000 common share purchase warrants of the 4,140,000 Blackrock warrants owned by the Company. As a result of such warrant exercise, the Company owns 9,780,000 common shares of Blackrock or 19.1% of Blackrock’s issued and outstanding shares on an undiluted basis.

The Company continues to hold 2,640,000 common share purchase warrants exercisable at \$0.20 until March 14, 2020, subject to accelerated expiry provisions. If the Company were to exercise all its warrants, it would hold approximately 24.2% of Blackrock’s issued and outstanding shares.
