Fonseca is a director and the President & CEO of the Issuer.

On November 6, 2019, Fonseca acquired 700,000 Goldplay Shares at a price of \$0.20/share in the Company’s private placement financing.

Prior to the issuance of these shares, Fonseca owned or controlled 5,229,889 Goldplay Shares. Upon issuance of these 700,000 Goldplay Shares, Fonseca now owns or controls 5,929,889 Goldplay Shares, representing approximately 8.7% of the outstanding Goldplay Shares, on a non-diluted basis.

On a partially diluted basis (assuming the exercise of all 1,367,514 stock options and 28,312 warrants owned or controlled by Fonseca), Fonseca would have ownership and control over approximately 10.5% of the then issued Goldplay Shares.
