On September 20, 2024, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 15,625,000 Shares of the Corporation at a price of \$0.32 per Share. The Shares were purchased from the Corporation pursuant to a private placement. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition of 15,625,000 Shares resulted in an increase of holdings of approximately 4.9% of the outstanding Shares on a partially diluted basis. from what was reported in the last early warning report. See items 2.2 and 3.4.

Mr. Sprott acquired beneficial ownership of the Shares. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned 25,131,819 Shares and 6,250,000 Warrants representing approximately 9.8% of the outstanding Shares on a non-diluted basis and 11.9% on a partially-diluted basis assuming the exercise of such Warrants.

Mr. Sprott now beneficially owns 40,756,819 Shares and 6,250,000 Warrants representing approximately 15.0% of the outstanding Shares on a non-diluted basis and 16.9% on a partially-diluted basis assuming the exercise of such Warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
