The Acquiror, a holding company owned and controlled by Laurie Baggio, an officer and director of the Issuer, entered into the Debt Settlement Agreement, dated as of November 2, 2018, as amended by Amendment No. 1, dated November 8, 2018, with the Issuer wherein \$99,051 in debt would be settled through the issuance of 1,100,563 common shares (the “**Acquired Shares**”) in the capital of the Issuer at a price of \$0.09 per share. The Issuer issued the Acquired Shares on November 9, 2018.

Prior to the issuance of the Acquired Shares, Mr. Baggio had ownership, direction and control of 1,146,737 common shares of the Issuer, representing 6.2% of the Issuer's issued and outstanding common shares.

The debt settlement was completed on November 9, 2018 and upon its completion, Mr. Baggio has ownership, direction and control of 2,404,524 Common Shares of the Issuer, representing 10.0% of the Issuer's issued and outstanding common shares.

The number of issued and outstanding common shares of the Issuer increased from 21,313,649 to 22,414,212.
