On December 8, 2020, Mr. Sprott donated 2,735,744 Shares to The Sprott Foundation (which is controlled by Mr. Sprott).

The 2,735,744 Shares that were donated to The Sprott Foundation, along with previous treasury Share issuances by the Corporation and previous share consolidation, resulted in a decrease in holdings of approximately 7.7% of the outstanding Shares on a partially diluted basis from what was reported in the last early warning report.

Sprott disposed of beneficial ownership of, but retained control over, the 2,735,744 Shares. See item 2.2

Prior to the donation of these Shares, Mr. Sprott beneficially owned and controlled 4,293,143 Shares and 94,500 Share purchase warrants representing approximately 13.4% of the outstanding Shares on a non-diluted basis and approximately 13.6% on a partially diluted basis assuming exercise of such warrants.

As a result of the donation, Mr. Sprott now beneficially owns and controls 1,557,399 Shares and 94,500 Share purchase warrants representing approximately 4.9% of the outstanding Shares on a non-diluted basis and approximately 5.1% on a partially diluted basis assuming the exercise of such warrants, but still controls 2,735,744 Shares, representing a total control of approximately 13.4% of the outstanding Shares on a non-diluted basis and approximately 13.6% on a partially diluted basis.

The Shares were donated to The Sprott Foundation. Mr. Sprott has a long-term view of the investment and may acquire additional securities of the Corporation including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
