On September 24, 2020, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 1,715,000 Units of the Corporation at a price of \$0.35 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.45 per Share and has a term of 36 months. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition results in Mr. Sprott's beneficial ownership of the Corporation to decrease by approximately 2.2% of the outstanding Shares on a partially diluted basis from what was reported in the most recent early warning report.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned and controlled 17,999,999 Shares and 17,999,999 Share purchase warrants representing approximately 19.6% of the then outstanding Shares on a non-diluted basis and 32.8% on a partially diluted basis assuming exercise of such warrants.

After giving effect to the Acquisition, Mr. Sprott beneficially owns and controls 19,714,999 Shares and 18,857,499 Share purchase warrants of the Corporation representing approximately 18.7% of the outstanding Shares on a non-diluted basis, and approximately 31.0% on a partially diluted basis assuming the exercise of all of such Share purchase warrants.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer
