On September 12, 2025, a total of 2,000,000 Warrants with exercise price of \$0.75 per Share held by 2176423 Ontario (a corporation beneficially owned by Mr. Sprott) were exercised, resulting in (i) Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 1.3% on a partially diluted basis since the date of the last early warning report and (ii) Mr. Sprott’s beneficial ownership position to decrease to below 10% on a non-diluted basis.

The exercise of 2,000,000 Warrants (along with intervening Share issuances by the Corporation) resulted in a decrease in holdings of approximately 1.3% of the Shares outstanding on a partially diluted basis from what was reported in the most recent early warning report. See items 2.2 and 3.4.

Prior to the exercise of these Warrants, Mr. Sprott beneficially owned 7,571,400 Shares and 3,785,700 Warrants, representing approximately 6.6% of the outstanding Shares on a non-diluted basis and 9.5% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott now beneficially owns 9,571,400 Shares and 1,785,700 Warrants, representing approximately 8.2% of the outstanding Shares on a non-diluted basis and 9.5% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
