On October 12, 2018 Mr. Chou disposed of 5,161,290 common shares of the Issuer at a price of \$0.775 per common share over the facilities of the TSX Venture Exchange (the “**Cross**”). On October 15, 2018, the Issuer completed a non-brokered private placement (the “**Private Placement**”) pursuant to which Mr. Chou acquired 1,935,483 common shares at a price of \$0.775 per common share for gross proceeds to the Issuer of \$1,500,000.

Prior to the Private Placement and Cross, Mr. Chou held 22,993,548 common shares and nil share purchase warrants, which represented 43.56% of the 52,787,109 common shares then issued and outstanding on an undiluted and partially-diluted basis. Following completion of the Private Placement and Cross, Mr. Chou owns or controls 19,767,741 common shares, or approximately 36.12% of the 54,722,592 issued and outstanding common shares of the Issuer on an undiluted and partially-diluted basis.

The common shares sold by Mr. Chou in the Cross were sold at a price of \$0.775 per common share for aggregate proceeds of \$3,999,999.75. The common shares purchased by Mr. Chou under the Private Placement were acquired at a price of \$0.775 per common share for an aggregate purchase price of \$1,499,999.33.
