On December 7, 2023, the Acquiror acquired 750,000 Common Shares at a price per Common Share of \$0.0001 and an aggregate purchase price of \$75.00 (the “**Acquisition**”). The Acquisition took place as a result of the closing of the Offering described in Item 1.2, above.
