Based on the number of currently issued and outstanding common shares as at July 31, 2022 (as reported by the issuer), there has been a net increase of 0.69% in Rosseau's securityholding percentage.

As at July 31, 2022, Rosseau exercises control or direction, on behalf of accounts fully managed by it, over 16,387,000 common shares and 5,149,500 warrants of the issuer.
