On September 26, 2022, the Issuer closed a financing of units (the “**Transaction**”), bringing the Issuer’s total number of shares issued and outstanding to 77,596,716, which resulted in Plethora’s securityholdings of the Issuer to drop below 10%.

Plethora owns 7,651,001 common shares of the Issuer, which represented 11.26% of the Issuer's issued and outstanding common shares prior to the Transaction on both an undiluted and partially diluted basis.

Following the Transaction, Plethora's securityholding percentage has been diluted to 9.86% of the Issuer's issued and outstanding common shares on both an undiluted and partially diluted basis.

The occurrence of the Transaction, which dropped Plethora's securityholding percentage to 9.86% of the Issuer's issued and outstanding common shares on both an undiluted and partially diluted basis, triggered the requirement to file this report.
