I, Anton Jelic, the Chief Financial Officer of Polaris Infrastructure Inc., certify the following:

(ii) information required to be disclosed by the issuer in its annual filings, interim filings or other reports filed or submitted by it under securities legislation is recorded, processed, summarized and reported within the time periods specified in securities legislation; and

(b) designed ICFR, or caused it to be designed under our supervision, to provide reasonable assurance regarding the reliability of financial reporting and the preparation of financial statements for external purposes in accordance with the issuer’s GAAP.

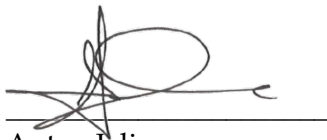
the Committee of Sponsoring Organizations of the Treadway Commission.
