MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The Fund’s objective is to increase the value of your investment over the long term by investing in equities of well-established U.S. companies that may be undervalued by the marketplace.

The portfolio manager examines the financial statistics of each potential investment by looking for attractive prices, consistent earnings, and evidence that the company’s management believes in the company’s future. The portfolio manager ranks the potential investments and the highest-ranked securities are included in the portfolio. The portfolio manager may use general environmental, social and governance (ESG) integration in the security selection process.

Risk

The risks associated with an investment in the Fund remain as disclosed in the Fund’s most recent simplified prospectus or any amendments thereto and fund facts. During the Period, there were no changes to the Fund that materially affected the overall risk level associated with an investment in the Fund. The Manager reviewed the Fund using the standardized investment risk classification methodology prescribed by National Instrument 81-102 *Investment Funds* and determined on May 30, 2023 that the risk rating of the Fund had not changed. The Manager reviews the Fund’s investment risk level and reference index, if any, at least annually.

Results of Operations

During the Period, the Fund’s total net asset value changed from approximately \$1,115 million to approximately \$918 million. Series A units of the Fund returned 15.71%. Please see the *Past Performance* section for information on the performance returns of the Fund’s other series.

During the Period, the U.S. equity market displayed a robust increase, driven by optimism around a strong economic outlook. The U.S. Federal Reserve Board (“Fed”) signalled its interest rate-hiking cycle may be nearing its end, which benefited riskier assets. The S&P 500 Index gained 19.6%. The Information Technology sector outperformed while the Utilities sector lagged.

Over the past year, global central banks tightened their monetary policies in the face of above-target inflation measures. Geopolitical risks continued to affect equity markets, with the Russia-Ukraine conflict and U.S. tensions with China remaining top of mind. Higher short-term interest rates have presented investors with alternatives to equities to generate income. Narrow market breadth continued for much of the Period, as a handful of primarily mega-capitalization information technology and communication services companies drove much of the market’s performance.

The Fund’s security selection within the Communication Services sector contributed to performance as many companies negatively affected by the 2022 market sell-off rebounded over the Period. The Fund’s underweight exposure to the Utilities sector contributed to performance in what was a largely risk-on Period for the markets. The

Fund's overweight exposure to the Consumer Discretionary sector contributed as consumer-focused companies performed reasonably well due to persistent consumer spending. Individual contributors included Adobe Inc., as the company continued to demonstrate a strong fundamental outlook and good results, and Booking Holdings Inc., as consumers continued to spend on experiences such as travel. Shares of Meta Platforms Inc. recovered from 2022 capital expenditure-induced selloff.

The Fund's security selection within the Health Care sector detracted from performance as defensive sectors underperformed. The Fund's security selection within the Information Technology sector detracted from performance as the Fund held underweight positions in some of the better-performing companies. The Fund's security selection within the Consumer Discretionary sector also detracted from performance largely due to positions in Tapestry Inc. and Advance Auto Parts Inc.

Individual detractors included the Fund's underweight position in NVIDIA Corporation, while CVS Health Corp. struggled with margin pressures, and Extra Space Storage Inc. underperformed. Sectors that are more sensitive to interest rates, such as real estate investment trusts, faced challenges.

New positions included Expedia Group Inc. due to trends in consumer spending and travel, Jacobs Solutions Inc. as it benefited from infrastructure spending, and Cardinal Health due to improving fundamentals. Eliminated positions included Bristol-Myers Squibb Co. due to its full valuation and slowing pipeline. CBRE Group Inc. was also eliminated due to the difficult commercial real estate environment, and Home Depot was eliminated due to slowing comparable store sales.

Increased positions included Electronic Arts Inc. due to solid fundamentals and attractive valuation based on the portfolio manager's model. Citigroup Inc. similarly had an attractive valuation, while Mastercard Inc. had their credit card spending remain on track and fundamentals were intact. Decreased positions included Adobe Inc., which was trimmed to manage overall position size, and Capital One, which was trimmed to reduce the Fund's bank exposure.

Multi-Series Structure Change

On May 30, 2023, the Manager launched Classic Series Units of the Fund.

As at the close of business on September 18, 2023, Series D Units of the Fund were redesignated to Advisor Series Units.

Corporate Class Merger

On August 25, 2023, the BMO U.S. Equity Class merged into the Fund on a tax deferred basis.

Recent Developments

The portfolio manager expects higher short-term interest rates to persist into 2024 due to inflation readings remaining above central bank targets. This potentially higher-for-longer interest rate environment also makes an economic slowdown or recession more likely in the coming quarters.

As a result, the portfolio manager continues to position the portfolio so that it holds attractively valued, higher-quality, profitable companies that should perform relatively well even in a slowing economic environment.

RELATED PARTY TRANSACTIONS

From time to time, the Manager may, on behalf of the Fund, enter into transactions or arrangements with or involving other members of BMO Financial Group, or certain other persons or companies that are related or connected to the Manager (each, a "Related Party"). The purpose of this section is to provide a brief description of any transaction involving the Fund and a Related Party.

Manager

BMO Investments Inc., an indirect, wholly-owned subsidiary of Bank of Montreal ("BMO"), is the Manager and trustee of the Fund. The Manager is paid a management fee by the Fund as compensation for its services, which is described in the "Management Fees" section later in this document.

Administration Fee and Operating Expenses

The Fund pays a fixed administration fee to the Manager in respect of each series other than Series I. The Manager in return pays the operating expenses of these series of the Fund, other than certain specified expenses that are paid directly by the Fund ("Fund Expenses"). Fund Expenses are allocated proportionately among the relevant series. If the Fund Expenses are specific to a series, the Fund Expenses are allocated to that series. The fixed administration fee is calculated as a fixed annual percentage of the net asset value of each relevant series of the Fund. The annual fixed administration fee rate for each series of the Fund, other than Series I, is 0.25%. The administration fee is subject to applicable taxes. The Manager may, in certain cases, waive a portion of the administration fee that it receives from the

Fund or from certain series of the Fund. Separate fees and expenses are negotiated and paid directly by each Series I investor. Further details about the fixed administration fee, Fund Expenses and/or operating expenses can be found in the Fund's most recent simplified prospectus at www.bmogam.com/ca-en/legal-and-regulatory/ or www.sedarplus.ca.

Buying and Selling Securities

During the Period, the Fund relied on standing instructions provided by the independent review committee ("IRC") for any of the following related party transactions that may have occurred in the Fund (each, a "Related Party Transaction"):

- (a) investments in securities issued by BMO, an affiliate of the Manager, or any other issuer related to the Manager;
- (b) investments in a class of securities of an issuer during the period of distribution of those securities to the public and/or the 60-day period following the distribution period where BMO Nesbitt Burns Inc., an affiliate of the Manager, or any other affiliate of the Manager acted as an underwriter in the distribution;
- (c) trades in over-the-counter debt securities in the secondary market with BMO Nesbitt Burns Inc., or any other affiliate of the Manager, acting as principal in the Canadian debt securities market; and
- (d) trades of a security of any issuer from or to, another investment fund managed by the Manager or an affiliate of the Manager or a managed account managed by the Manager or an affiliate of the Manager.

In accordance with the IRC's standing instructions, in making a decision to cause the Fund to enter into a Related Party Transaction, the Manager and the portfolio manager of the Fund are required to comply with the Manager's written policies and procedures governing the Related Party Transaction and report periodically to the IRC, describing each instance that the Manager relied on the standing instructions and its compliance or non-compliance with the governing policies and procedures. The governing policies and procedures are designed to ensure that each Related Party Transaction (i) is made free from any influence of BMO, BMO Nesbitt Burns Inc. or an associate or affiliate of BMO and/or BMO Nesbitt Burns Inc., and without taking into account any considerations relevant to BMO, BMO Nesbitt Burns Inc. or an associate or affiliate of BMO and/or BMO Nesbitt Burns Inc.; (ii) represents the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; and (iii) achieves a fair and reasonable result for the Fund.

Distribution Services

The Manager markets and distributes the Fund through BMO branches and/or (depending on the series) through registered dealers and brokers, including BMO InvestorLine Inc. and BMO Nesbitt Burns Inc., both affiliates of the Manager. The Manager pays to these affiliates a service fee called a "trailing commission" based on the average daily value of the units that are held in investor accounts. This service fee is paid monthly or quarterly and varies by purchase option and by series.

Management Fees

The Manager is responsible for the day-to-day management of the business and operations of the Fund. The Manager monitors and evaluates the Fund's performance, pays for the investment advice provided by the Fund's portfolio manager and provides certain administrative services required by the Fund. As compensation for its services, the Manager is entitled to receive a management fee payable monthly, calculated based on the daily net asset value of each series of the Fund at the annual rate set out in the table below. The management fee is subject to applicable taxes. The Manager may, at its discretion, waive a portion or the entire amount of the management fee chargeable at any given time for each series of the Fund.

The returns of each series may differ from one another for a number of reasons, including if the series was not issued and outstanding for the entire reporting period and because of the different levels of management fees and expenses allocated and payable by each series.

On December 15, 2013, BMO Nesbitt Burns U.S. Stock Selection Fund merged into the Fund.

On August 31, 2016, BMO Asset Management Inc. became the portfolio manager of the Fund and BMO Asset Management Corp. became the sub-advisor of the Fund.

On February 1, 2017, the management fee on Series F and Series F (Hedged) units was lowered from 0.60% to 0.50%.

On December 16, 2021, Columbia Management Investment Advisers, LLC replaced BMO Asset Management Inc. as portfolio manager of the Fund, and BMO Asset Management Corp. ceased to act as sub-advisor of the Fund.


On August 25, 2023, BMO U.S. Equity Class merged into BMO U.S. Equity Fund.


Series A Units



Series A (Hedged) Units










