On December 30, 2020 (the “Date of Issuance”), the Issuer completed a non-brokered private placement financing (the “Private Placement”) for total gross proceeds of \$753,000 and issued an aggregate of 11,584,615 shares at a price of \$0.065 per share. The shares are listed on the TSX Venture Exchange.

Pursuant to the Private Placement, Gentile acquired 11,584,615 shares of the Issuer at a price of \$0.065 per share for total consideration payable to the Issuer of \$753,000 (the “Acquisition”).

Prior to the completion of the Acquisition, Gentile beneficially owned and controlled, directly or

indirectly, an aggregate of 11,765,333 Common Shares and an aggregate of 5,000,000 Common Share purchase warrants (the “**Warrants**”), representing approximately 10.29% of the Company’s issued and outstanding Common Shares on an undiluted basis and approximately 14.04% of the Company’s issued and outstanding Common Shares on a partially diluted basis. Following the completion of the Acquisition, Mr. Gentile beneficially owns and controls, an aggregate of 23,349,948 Common Shares and 5,000,000 Warrants, representing approximately 16.99% of the Company’s issued and outstanding Common Shares an undiluted basis and approximately 19.90% of the Company’s issued and outstanding Common Shares on a partially diluted basis.

In the future, Gentile, will evaluate his investment in the Issuer from time to time and may, based on such evaluation and the market conditions and other circumstances, increase or decrease his security holdings through market transactions, private agreements, or otherwise.
