STATEMENT OF RESERVES DATA

METALORE RESOURCES LIMITED

This reserves and cash flow evaluation of Metalore Resources Limited was prepared on May 22, 2018 using production and revenue data up to and including March 31, 2018 in a report entitled Metalore Resources Limited Reserves and Present Value Estimate as of March 31, 2018 prepared by Jim McIntosh Petroleum Engineering Ltd. The results of this report are summarized in the tables below.

All of Metalore Resources Limited natural gas assets are located onshore in south-western Ontario, Canada. The company has 100% working interests in 80 producing Silurian-aged Thorold/Grimsby sandstone gas wells in the Charlotteville Township area of Norfolk County and 52% working interests in 5 shut-in Silurian-aged Thorold/Grimsby sandstone gas wells in Houghton Township, Norfolk County. In addition to the producing wells, Metalore has undeveloped but highly prospective acreage in both areas.

**REPORT ON RESERVES DATA

To the board of directors of Metalore Resources Limited (the “Company”)

1. I have evaluated the Company’s reserves data as at March 31, 2018. The reserves data are estimates of proved reserves and probable reserves and related future net revenue as at March 31, 2018, estimated using forecast prices and costs.
2. The reserves data are the responsibility of the Company’s management. My responsibility is to express an opinion on the reserves data based on my evaluation.

I carried out my evaluation in accordance with standards set out in the Canadian Oil and Gas Evaluation Handbook (the “COGE Handbook”) prepared jointly by the Society of Petroleum Evaluation Engineers (Calgary Chapter) and the Canadian Institute of Mining, Metallurgy & Petroleum (Petroleum Society).


3. Those standards require that I plan and perform an evaluation to obtain reasonable assurance as to whether the reserves data are free of material misstatement. An evaluation also includes assessing whether the reserves data are in accordance with principles and definitions presented in the COGE Handbook.

The following table sets forth the estimated future net revenue (before deduction of income taxes) attributable to proved plus probable reserves, estimated using forecast prices and costs and calculated using a discount rate of 10 percent, included in the reserves data of the Company evaluated by me for the year ended March 31, 2018, and identifies the respective portions thereof that I have evaluated and reported on to the Company’s management:

(ii) the related standardized measure of discounted future net cash flows from oil and gas reserve quantities.

An independent qualified evaluator has evaluated and reviewed the Company's Reserves Data. The report of the independent qualified evaluator will be filed with SEDAR concurrently with this report.

The AUDIT Committee of the board of directors has reviewed the Company's procedures for assembling and reporting other information associated with oil and gas activities and has reviewed that information with management. The board of directors has approved the content and filing of the Reserves Data and other oil and gas information, the filing of the report of the independent qualified evaluator on the Reserves Data and the content and filing of this report.
