On August 27, 2024, Mr. Gentile exercised 5,000,000 Common Share purchase warrants (the "**Warrants**") in the capital of the Company at an exercise price of \$0.12 per Warrants (the "**Exercise**")

Prior to Exercise, Mr. Gentile held 30,049,502 Common Shares and 8,349,777 Warrants, representing approximately 14.90% of the Company's then-issued and outstanding Common Shares

on an undiluted basis and approximately 18.27% of the Company's then-issued and outstanding Common Shares on a partially diluted basis. Following the completion of the Exercise, Mr. Gentile beneficially owns and controls an aggregate of 35,049,502 Common Shares and 3,349,777 Warrants, representing approximately 16.96% of the Company's issued and outstanding Common Shares on an undiluted basis and approximately 18.27% of the Company's issued and outstanding Common Shares on a partially diluted basis.
