On May 10, 2021, the Acquiror, by way of private placement, acquired a total of 4,000,000 Units of the Issuer at a price of CAD \$0.10 per Unit for gross proceeds of CAD \$400,000 (the “**Transaction**”). Each Unit consists of one common share (a “**Share**”) and one-half of one common share purchase warrant

(a “**Warrant**”) of the Issuer. Each whole Warrant is exercisable into a Share at a price of CAD \$0.20 expiring on May 10, 2023. The Transaction resulted in the acquisition of more than 10% of the issued and outstanding common shares of the Issuer by the Acquiror.

Prior to the Transaction, Plethora owned 4,600,000 Shares of the Company and 2,200,000 Warrants of the Company, representing 6.83% and 9.78% of the Company’s issued and outstanding common shares on an undiluted and partially diluted basis respectively.

Following the Transaction, Plethora now owns or controls an aggregate 8,600,000 common shares, and 4,200,000 common share purchase warrants, representing 15.38% of the Company’s issued and outstanding common shares on a partially diluted basis. On an undiluted basis, Plethora’s ownership after the Transaction represents 10.88% of the Company’s issued and outstanding common shares.

The Acquiror paid gross proceeds of CAD \$400,000 for the acquisition of 4,000,000 Units of the Issuer at a price of \$0.10 CAD per Unit.
