MANAGEMENT'S DISCUSSION & ANALYSIS FOR THE YEAR ENDED DECEMBER 31, 2023 the "Reporting Period")

This Management Discussion and Analysis ("MD&A") of Bigstack Opportunities I Inc. ("Bigstack" or the "Company") has been prepared by management as of March 14, 2024 and should be read in conjunction with the audited financial statements and related notes thereto of the Company as at and for the year ended December 31, which was prepared in accordance with International Accounting Standards using accounting policies consistent with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB") and International Financial Reporting Interpretations Committee ("IFRIC"). This MD&A contains forward-looking information which reflects management's expectations regarding the Company's growth, results of operation, performance and business prospects and opportunities. The use of words such as "anticipate", "continue", "estimate", "expect", "may", "will", "project", "should", "believe", "outlook", "forecast" and similar expressions are intended to identify forward-looking statements. Overall Performance:

The Company was incorporated under the *Business Corporations Act* (Ontario) on November 25, 2020 and is a Capital Pool Company (the "CPC") as defined in the Policy 2.4 by the TSX Venture Exchange Inc. (the "Exchange").

On December 10, 2020, the Company's founding directors and officers subscribed for an aggregate of 4,020,001 common shares (the "Seed Shares") at \$0.05 per share for gross proceeds of \$200,001.

On May 10, 2021, the Company closed a private placement with a director of the Company for 240,000 common shares at \$0.05 per share for total proceeds of \$12,000.

On July 16, 2021, the Company completed its initial public offering ("IPO") through its agent, Echelon Wealth Partners Inc. ("Echelon") of 5,000,000 common shares at a price of \$0.10 per share, raising aggregate proceeds of \$500,000.

The Company's business is to identify and evaluate businesses and assets with a view to completing a "Qualifying Transaction" as defined in the policies of the Exchange. Any proposed Qualifying Transaction must be accepted by the Exchange and, in the case of a non-arm's length Qualifying Transaction, is also subject to "majority of the minority approval" in accordance with Exchange Policy 2.4 – *Capital Pool Companies*.

The Company has not commenced operations and has no assets other than cash and short term investments. The Company's continuing operations as intended are dependent upon its ability to identify, evaluate and negotiate an acquisition, or business, or an interest therein. There is no assurance that the Company will identify a Qualifying Transaction within the time limitations permissible under the policies of the Exchange, at which time the Exchange may suspend or delist the Company's shares from trading. Such an acquisition will be subject to the approval of the regulatory authorities concerned and in the case of a non-arms' length transaction, of the majority of the minority shareholders.

Results of Operations:

As at December 31, 2023 the Company has no commercial operations. In the twelve month period ended December 31, 2023, the Company generated \$12,256 (2022 - \$Nil) in interest revenue and incurred \$28,424 (2022 - \$49,601) in operating expenses. These operating expenses related primarily to costs associated with being a public company, including such as expenses as public company filing fees and annual audit related fees. Management continues to review business opportunities for the CPC while controlling expenses within the CPC guidelines.

Liquidity and Capital Resources:

As at December 31, 2023 the Company has working capital of \$494,373. Management believes that the Company has sufficient cash on hand to meet its current obligations for the next 12 months. In the future, the Company may have capital requirements in excess of its currently available resources and the other sources of funds potentially available to the Company are through the exercise of outstanding stock options (313,000 exercisable options @ \$0.05 and 589,000 @ \$0.10). In the event that the Company's plans change, its assumptions change or prove inaccurate, or its capital resources in addition to projected cash flow, if any, prove to be insufficient to fund operations, the Company may be required to seek additional financing, subject to the TSX-V policies and approval. There can be no assurance that the Company will have sufficient financing to meet its future capital requirements or that additional financing will be available on terms acceptable to the Company in the future.

There are no commitments for capital expenditures as at December 31, 2023.

Liabilities:

The Company's present liabilities are limited to trade payables incurred in the normal course of day to day business.

Off-Balance Sheet Arrangements:

The Company does not have any off-balance sheet arrangements.

As at December 31, 2023, the Company had commitments for cash resources of \$12,090 which are detailed below. The available cash on hand is sufficient to pay these commitments as at December 31, 2023:

Related Party Transactions and Balances:

During the year ended December 31, 2023 and 2022, the Corporation incurred rent and legal fees to a law firm whose partner is a director of the Corporation. An amount of \$4,520 (2022 - \$13,560) has been included in rent, while an amount of \$Nil (2022 - \$700) was incurred in relation to legal fees. An amount is included in accounts payable and accrued liabilities of \$Nil (2022 - \$Nil) owing to this law firm.

There were no other transactions with related parties and no remuneration was paid to key management personnel during the twelve month periods ended December 31, 2023 and December 31, 2022.

All transactions with related parties have occurred in the normal course of operations.

All of the Seed Shares and Options issued are subject to an Escrow Agreement. Under the Escrow Agreement, 25% of the escrowed common shares will be released from escrow on the completion of the Company's QT, as defined in the policies of the Exchange, and as to 25% on each of the dates which are 6, 12, 18, months following the Initial Release.

Financial Instruments and Other Instruments:

The Company maintains its cash in deposit accounts and its GICs with Schedule A financial institutions which, at times, may exceed federally insured limits. The Company has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk.

Internal Controls Over Financial Reporting:

Management's Report on Disclosure Controls and Procedures:

Disclosure controls and procedures have been designed to provide reasonable assurance that all material information related to the Company is identified and communicated on a timely basis. Management of the Company is responsible for the design and operations of disclosure controls and internal control over financial reporting.

There have been no changes in the Company's disclosure controls and procedures during the period ended December 31, 2023.

Internal Control over Financial Reporting:

The Company's management is responsible for establishing and maintaining adequate internal controls over financial reporting to provide reasonable assurance regarding the reliability of financial reporting and preparation of the financial statements for external purposes in accordance with generally accepted accounting principles. However, the Company's management, including its Chief Executive Officer and Chief Financial Officer, believe that due to inherent limitations, internal control over financial reporting may not prevent or detect all misstatements and fraud or on a timely basis. Also, projections of any evaluation of the effectiveness of internal control over financial reporting to future periods are subject to the risk that the controls may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.

There have been no changes in the Company's internal control over financial reporting during the period ended December 31, 2023 that have materially affected or are reasonably likely to materially affect, the Company's internal control over financial reporting.

The Company has only limited funds with which to identify and evaluate potential Qualifying Transactions and there can be no assurance that the Company will be able to identify a suitable Qualifying Transaction. Further, even if a proposed Qualifying Transaction is identified, there can be no assurance that the Company will be able to complete the transaction. The Qualifying Transaction may be financed in whole, or in part, by the issuance of additional securities by the Company and this may result in further dilution to investors, which dilution may be significant and which may also result in a change of control of the Company.

At the present time, the company does not have any market, currency, interest or credit risk.

Segmented Information:

The Company has a single reportable geographic segment, Canada, and all of the Company's management and assets are located in Canada.

The internal reporting provided to management of the Company is prepared on a consistent basis with the measurement and recognition principles of IFRS.
