In connection with units purchased in a private placement by the Company, Mr. Berlet acquired an aggregate of 250,000 common shares (“**Common Share**”) at a price of Cdn\$0.08 per Common Share for an aggregate purchase price of Cdn\$20,000 (the “**Acquisition**”).

Following the Acquisition, Mr. Berlet now owns approximately 15,345,000 Common Shares and 295,000 Common Share purchase warrants (“**Warrant**”) representing approximately 11.37% of the issued and outstanding Common Shares on a non-diluted basis (approximately 11.56% on a partially diluted basis, assuming the exercise of all Warrants held by Mr. Berlet).

Immediately prior to the Private Placement, Mr. Berlet owned, directly or indirectly, or exercised control or direction over, approximately 15,095,000 Common Shares and 170,000 Warrants representing approximately 10.94% of the issued and outstanding Common Shares of the Company on a non-diluted basis (and representing approximately 11.06% on a partly diluted basis, assuming the exercise of all Warrants held by Mr. Berlet).

Following closing of the Private Placement, Mr. Berlet owned, directly or indirectly, or exercised control or direction over, approximately 15,345,000 Common Shares and 295,000 Warrants representing approximately 11.37% of the issued and outstanding Common Shares of the Company on a non-diluted basis (and representing approximately 11.56% on a partly diluted basis, assuming the exercise of all Warrants held by Mr. Berlet). As a result of the Private Placement, Mr. Berlet's ownership increased by 0.43%.
