Since July 26, 2018 the Acquiror purchased through the facilities of the Toronto Stock Exchange 1,867,200 Common Shares of Titan at purchase prices ranging from \$1.09 to \$1.30 per common share.

Prior to July 26, 2018 Mr. Warke owned directly or indirectly or exercised control or direction over 42,754,833 Common Shares of Titan representing 41.93% of the issued and outstanding Common Shares of Titan.

Since July 26, 2018 the Acquiror purchased 1,867,200 additional Common Shares of Titan. Mr. Warke also directly owns 666,667 stock options ("Options") that have vested or will vest in the next 60 days, each Option entitling Warke to purchase one Common Share. If all Options were exercised Mr. Warke would then own, directly or indirectly or exercise control or direction over 44.13% of the total number of issued and outstanding Common Shares of Titan resulting in an increase of 2.469% on a partially diluted basis.

The Acquiror acquired ownership of 1,867,200 Common Shares of Titan.

Since July 26, 2018 Mr. Warke owns, directly or indirectly or exercises control or direction over 44,622,033 Common Shares of Titan representing 43.76% of the issued and outstanding Common Shares of Titan and 666,667 Options that have vested or will vest in the next 60 days, each Option entitling Warke to purchase one Common Share. If all Options were exercised Mr. Warke would then own, directly or indirectly or exercise control or direction over 44.13% of the total number of issued and outstanding Common Shares of Titan resulting in an increase of 2.469% on a partially diluted basis.

Mr. Warke owns, directly or indirectly or exercises control or direction over 44,622,033 Common Shares representing 43.76% of the issued and outstanding Common Shares of Titan.

Mr. Warke owns 2,000,000 Options representing 20.16% of the issued and outstanding Options of Titan of which 666,667 Options have vested or will vest in the next 60 days.
