This report relates to the acquisition of common shares (“**Shares**”) of Five Star Diamonds Ltd. (the “**Issuer**”) pursuant to a debt settlement agreement (the “**Debt Settlement**”) that closed on December 21, 2018.

Luis Mauricio F. de Azevedo, and entities controlled by Mr. Azevedo, (the “**Acquiror**”) acquired under the Debt Settlement beneficial ownership of, or control or direction over, Shares, which together with the Acquiror’s current holdings of Issuer’s securities, constitutes 10% or more of the Issuer’s Shares issued and outstanding on a partially diluted basis.

On December 21, 2018, the Acquiror acquired a total of 1,373,060 Shares at a deemed price of \$0.20 for gross proceeds of \$274,612. As the Acquiror was

owed a total of \$274,612 by the Issuer, total consideration consisted of the settlement of outstanding amounts owed to the Acquiror (the “**Debt Settlement Transaction**”).

As a result of the Acquisition, the Acquiror beneficially owns, or exercises control or direction over more than 10% of the Issuer’s issued and outstanding Shares.

The Acquiror had ownership or direction and control over an aggregate of 12,295,282 Shares prior to the Debt Settlement Transaction, representing approximately 9.42% of the issued and outstanding Shares on a partially diluted basis. On an undiluted basis, the Acquiror owned 10,695,282 Shares, representing 8.29% of the issued and outstanding Shares.

Following the Debt Settlement Transaction, the Acquiror has ownership or direction or control over 13,668,342 Shares representing approximately 10.17% of the issued and outstanding Shares on a partially diluted basis. On an undiluted basis, the Acquiror now has ownership or direction or control over 12,068,342 Shares, representing 9.09% of the issued and outstanding Shares.

The Acquiror acquired ownership, control or direction over 1,373,060 Shares pursuant to the Debt Settlement Transaction.

The Acquiror settled outstanding debts of \$274,612 owed by the Issuer for the Shares acquired on December 21, 2018 under the Issuer's Debt Settlement.
