4. **Summary of Material Change**

On March 20, 2020, the Company has entered into a loan agreement with SinoTech (Hong Kong) Corporation Limited for a loan to the Company. Cathy Wang has resigned as the Chief Financial Officer and Corporate Secretary of the Company. The Company has appointed Mr. Mao Sun as the Company's new Chief Financial Officer and Corporate Secretary.

5.1 **Full Description of Material Change**

On March 20, 2020, the Company has entered into a loan agreement (the “**Loan Agreement**”) with SinoTech (Hong Kong) Corporation Limited (the “**Lender**”) for a loan to the Company in the principal amount of \$50,000 (the “**Principal Amount**”) for a term of one (1) year. The Principal Amount will bear interest at a fixed rate of 10% per annum.

The Loan Agreement is considered a “related party transaction” under Multilateral Instrument 61-101 Protection of Minority Security Holders in Special Transactions (“**MI 61-101**”). The Loan Agreement is exempt from the requirements to obtain a formal valuation pursuant to the exemption in section 5.5(b) of MI 61-101, as the Company is not listed on a specified market, and is exempt from minority shareholder approval pursuant to section 5.7(1)(f) of MI 61-101, as the Loan Agreement does not have an equity or voting component and is on reasonable commercial terms that are not less advantageous to the Company than if the Loan Agreement were obtained from an arm's length party.

Cathy Wang has resigned as the Chief Financial Officer and Corporate Secretary of the Company. The Company has appointed Mr. Mao Sun as the Company's new Chief Financial Officer and Corporate Secretary.
