On September 1, 2021, Kelligrew Inc. a private corporation controlled by the Acquiror acquired 49,300 common shares of the capital of the Company (the “Common Shares”) over the TSX Venture Exchange (the “Acquisition”).

After the Acquisition noted in paragraph 2.2 above, the Acquirer will directly own 211,667 common shares of the Company, RRSP holdings of 578,667 and indirectly owns 5,589,300 common shares of the Company through Kelligrew Inc. and Brigus Capital Inc., companies controlled by the Acquirer. The Acquirer also holds 425,000 stock options of the Company

As a result of the Acquisition noted in paragraph 2.2 above, the Offeror owns, directly or indirectly, a total of 6,379,634 common shares and 425,000 stock options of the Company, representing approximately 26.3% of the 24,231,667 issued and outstanding common shares of the Company as at September 1, 2021, or approximately 28.1% of the Company's issued and outstanding common shares calculated on a partially-diluted basis assuming the exercise of the Offeror's stock options.
