

NOTICE OF ANNUAL GENERAL AND SPECIAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that an annual general and special meeting (the “**Meeting**”) of the holders of common shares of Harvest Gold Corporation (the “**Company**”) will be held by Zoom on Thursday, January 5, 2023 at 11:00 a.m. (Vancouver Time) for the following purposes:

1. To receive the audited financial statements of the Company for the financial year ended March 31, 2022, the auditor’s report thereon and the management’s discussion and analysis for the financial year ended March 31, 2022;
2. To receive the audited financial statements of the Company for the financial year ended March 31, 2021, the auditor’s report thereon and the management’s discussion and analysis for the financial year ended March 31, 2021;
3. To re-appoint Dale Matheson Carr-Hilton Labonte LLP, Chartered Professional Accountants, as auditors for the ensuing year and to authorize the directors to fix the auditor’s remuneration;
4. To fix the number of directors for the ensuing year at five (5);
5. To elect directors of the Company for the ensuing year;
6. To approve the adoption of a new 10% rolling stock option plan of the Company, as more particularly described in the Company’s management information circular (the “**Circular**”); and
7. To transact any other business that may properly come before the Meeting and any adjournment thereof.

Accompanying this notice is the Circular. The Circular contains details of matters to be considered at the Meeting.

The Meeting will be held in **virtual only format**, which will be conducted via Zoom. Registered shareholders and validly appointed proxyholders may attend the Meeting by Zoom using the below web link. Registered shareholders who attend the virtual Meeting will have an equal opportunity to participate at the Meeting, regardless of their geographic location.

Alternatively, you may vote by telephone or via the internet following the instructions provided on the Proxy and in the Circular.

If you are a beneficial holder and have received this Notice of Meeting and accompanying materials through an intermediary, such as an investment dealer, broker, custodian, administrator or other nominee, or a clearing agency in which the intermediary participates, please complete and return the voting instruction form provided to you in accordance with the instructions provided therein.
