On December 19, 2019, L8 completed a sale of an aggregate of 3,000,000 Common Shares through the Share Purchase Agreement (the "**Transaction**").

On December 19, 2019, L8 completed a sale of an aggregate of 3,000,000 Common Shares, representing approximately 3.76% of the issued and outstanding Common Shares on a partially-diluted basis (on the basis of 79,863,851 Common Shares, which represents the issued and outstanding as of the date hereof, assuming the exercise of all of the convertible securities held by L8).

L8 disposed of beneficial ownership of and control and direction over the Common Shares of the Company that triggered the requirement to file this report.

Immediately following the transactions that triggered the obligation to issue this press release, L8 had beneficial ownership of and exercised control or direction over 6,304,308 Common Shares, representing approximately 7.89% of the issued and outstanding Common Shares on a partially diluted basis (based on 79,863,851 Common Shares issued and outstanding as of the date of this report).
