MMCAP International Inc. SPC ("**MMCAP**") is an investment fund advised by MM Asset.

- 2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

The requirement to file this report was triggered on November 1, 2017 when MM Asset, on behalf of MMCAP, participated in a private placement of convertible debenture units ("**Units**") of the Issuer and acquired control and direction over 28,000 Units. Each Unit comprised of \$1,000 principal amount of 8% senior unsecured convertible debentures (the "**November Debentures**") maturing on November 1, 2022 (the "**Maturity Date**") and 833 common share purchase warrants (each, a "**November Warrant**") of the Issuer. The November Debentures are convertible at the option of the holder into Shares prior to the

Maturity Date at a conversion price of \$1.20 per Share. Each November Warrant is exercisable for one Share at a price of \$1.20 prior to November 1, 2019.

MM Asset is eligible to file reports under Part 4 of National Instrument 62-103 ("**NI 62-103**") in respect of the Issuer.

Since the last report filed on November 10, 2017, MM Asset, on behalf of MMCAP, has:

- (a) acquired control and direction over 28,000 Units as described in Item 2.2 above;
- (b) converted the November Debentures into 23,333,333 Shares; and
- (c) disposed of 2,501,500 common share purchase warrants, each warrant entitling the holder to purchase one Share at a price of \$1.50 per share prior to June 29, 2019 (the "**June Warrants**") through open market transactions on the TSX Venture Exchange,

representing a net increase of approximately 9.77% of the Issuer's 263,559,324 outstanding Shares as reported by the Issuer in its Management's Discussion and Analysis of Financial Results dated November 28, 2017 (the "**Outstanding Shares**").

At the end of November 2017, MM Asset, on behalf of MMCAP, exercised control and direction over:

- (a) 6% senior unsecured convertible debentures (the "**June Debentures**") maturing on June 29, 2019 (the "**June Maturity Date**") in the aggregate principal amount of \$20,472,000. The June Debentures are convertible at the option of the holder into Shares prior to the Maturity Date at a conversion price of \$1.00 per Share;
- (b) 4,622,999 June Warrants;
- (c) 23,324,000 November Warrants; and
- (d) 23,333,333 Shares,

representing approximately 23% of the Outstanding Shares, calculated on a partially diluted basis.
