On July 23, 2020, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 23,000,000 Units of the Corporation at a price of \$0.085 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.12 per Share until July 23, 2022. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition results in an increase in holdings to greater than 10% of the outstanding Shares on a partially diluted basis. See items 2.2 and 3.4.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned and controlled 6,842,000 Shares representing approximately 5.3% of the outstanding Shares on a non-diluted basis.

After giving effect to the Acquisition, Sprott beneficially owns and controls 29,842,000 Shares and 11,500,000 Warrants, representing approximately 19.6% of the issued and outstanding Shares on a non-diluted basis, and approximately 25.2% on a partially diluted basis assuming exercise of the Warrants.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer
