As a result of net sales of common shares of the Issuer (“**Common Shares**”) disposed by Crescat in July 2021, Crescat’s holdings in the Issuer have fallen below 10%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net decrease of 127,764 Common Shares in Crescat's holdings representing a decrease of approximately 1.43%.

As at July 31, 2021, Crescat exercised control over 10,469,146 Common Shares, representing approximately 5.05% of the outstanding Common Shares, and 10,466,666 Warrants. Assuming that the Warrants are exercised, Crescat will hold 20,935,812 Common Shares representing approximately 9.61% of the issued Common Shares on a partially diluted basis as at July 31, 2021.

As at July 31, 2021, Crescat and the Joint Actors collectively exercise control over a total of 10,669,146 Common Shares (representing approximately 5.15% of the outstanding Common Shares) and 10,666,666 Warrants. Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 21,335,812 Common Shares representing approximately 9.79% of the outstanding Common Shares on a partially diluted basis as at July 31, 2021.
