On July 23, 2022, a total of 11,500,000 Warrants with an exercise price of \$0.12 per common share of the Corporation (“**Share**”) held by 2176423 Ontario (a corporation beneficially owned by Eric Sprott) expired unexercised, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 10.8% on a partially diluted basis since the date of the last early warning report.

The 11,500,000 Warrants that expired represent a decrease in holdings of approximately 10.8% of the Shares outstanding on a partially diluted basis from what was reported in the last early warning report. See items 2.2 and 3.4.

Prior to the expiry of these Warrants, Mr. Sprott beneficially owned and controlled 29,842,000 Shares and 11,500,000 Warrants representing approximately 14.4% of the outstanding Shares on a non-diluted basis and approximately 18.9% on a partially diluted basis assuming the exercise of such Warrants.

Mr. Sprott now beneficially owns and controls 29,842,000 Shares representing approximately 14.4% of the outstanding Shares on a non-diluted basis.

The Warrants expired unexercised. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
