On November 3, 2022, Decade completed the private placement transaction (the “**Private Placement**”) previously announced on September 6, 2022.

Prior to the Acquisition (as defined below), Mr. Beaty did not own, directly or indirectly, or exercise control or direction over, any securities of Decade.

Mr. Beaty purchased 5,000,000 Units, consisting of 5,000,000 Common Shares and 5,000,000 Warrants, pursuant to the Private Placement (the “**Acquisition**”). As a result of the Acquisition, Mr. Beaty now owns, directly or indirectly, or exercises control or direction over, 5,000,000 Common Shares, representing approximately 7.67% of the issued and outstanding Common Shares. If all of Mr. Beaty’s 5,000,000 Warrants were exercised, Mr. Beaty would own, directly or indirectly, or exercise control or direction over, approximately 14.25% of the issued and outstanding Common Shares, on a partially diluted basis.

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.

Mr. Beaty acquired ownership of 5,000,000 Units, consisting of 5,000,000 Common Shares and 5,000,000 Warrants.

If all of Mr. Beaty’s 5,000,000 Warrants were exercised, Mr. Beaty would own, directly or indirectly, or exercise control or direction over, approximately 14.25% of the issued and outstanding Common Shares, on a partially diluted basis.
