On December 30, 2024, Investmentaktiengesellschaft für langfristige Investoren TGV ("**IFL**") transferred to Norman Rentrop from its investment fund by way of a redemption in kind 1,413,439 Issuer shares (the "**Shares**") held by IFL representing 12.84% of the outstanding Common Shares of the Issuer. As a result, NR has become the beneficial owner of the 12.84% Common Share position held by IFL.

In connection with the redemption in kind, NR received the Shares for a deemed consideration of CA\$ 33,131,010.16 representing the market value of the Shares based on the December 27 closing market price of the Shares on the Toronto Stock Exchange.
