Probity Mining 2025 Short Duration Flow Through Limited Partnership purchased 3,333,334 Common Shares and 3,333,334 Warrants of the Issuer on October 9, 2025, pursuant to a private placement offering (the “Offering”) of units (the “Units”) conducted by the Issuer.

Probity Mining 2024 – II Short Duration Flow Through Limited Partnership and the Probity Mining 2025 Short Duration Flow Through Limited Partnership are

limited partnerships created pursuant to the laws of British Columbia for whom QIFM acts as an investment fund manager, portfolio manager and exempt market dealer.

2.3 State the name of any joint actors.

QIFM acts as an investment fund manager, portfolio manager and exempt market dealer for Probity Mining 2024-II Short Duration Flow Through Limited Partnership and Probity Mining 2025 Short Duration Flow Through Limited Partnership (together, the “Probity Funds”). The Probity Funds may be considered joint actors of QIFM. For the purpose of this report, QIFM aggregated the interest held by the Probity Funds. QIFM itself does not own any securities of the Issuer, but exercises control or direction over certain securities of the Issuer as the investment fund manager of the Probity Funds.

2.4 State that the eligible institutional investor is eligible to file reports under Part 4 in respect of the reporting issuer.

QIFM is eligible to file reports under Part 4 of National Instrument 62-103 in respect of the Issuer.

Immediately before the transactions that triggered the requirement to file this report, the Probity Funds held 5,785,715 Common Shares and 9,285,715 Warrants to acquire Commons Shares of the Issuer representing approximately 8.9% of the Issuer’s share capital on a post-conversion beneficial ownership basis. Immediately after the transactions that triggered the requirement to file this report and as of October 31, 2025, the Probity Funds held 9,119,049 Common Shares and 12,619,049 Warrants to acquire Common Shares of the Issuer representing approximately 10.3% of the Issuer’s share capital on a post-conversion beneficial ownership basis.

The Probity Funds hold 9,119,049 Common Shares and 12,619,049 warrants to acquire Common Shares of the Issuer as October 31, 2025 representing approximately 10.3% of the Issuer’s share capital on a post-conversion beneficial ownership basis.
