On October 15, 2024, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 10,000,000 Units of the Corporation at a price of \$0.60 per Unit. Each Warrant entitles the holder thereof to acquire one Share at a price of \$0.90 per Share until two years after the issuance of the Warrant. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition of 10,000,000 Units represent approximately 13.0% of the outstanding Shares on a non-diluted basis, and approximately 15.9% on a partially diluted basis, representing an increase in holdings to above 10% on a partially diluted basis. See item 3.4.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned 17,980,000 Shares and 2,423,333 Warrants, representing approximately 8.8% of the outstanding Shares on a non-diluted basis and 9.9% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants

Mr. Sprott now beneficially owns 27,980,000 Shares and 7,423,333 Warrants, representing approximately 13.0% of the outstanding Shares on a non-diluted basis and 15.9% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants. See also item 6.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
