On July 12, 2017, Mr. Isenor entered into agreements (the “**Option Agreements**”) granting him the option to purchase an aggregate of 4,520,000 common shares (“**Optioned Shares**”) of the Issuer at a price of \$0.05 per Optioned Share.

Item 3 – Interest in Securities of the Reporting Issuer

3.1 State the designation and number or principal amount of securities acquired or disposed of that triggered the requirement to file the report and the change in the acquiror’s securityholding percentage in the class of securities.

Mr. Isenor entered into the Option Agreements granting him the option to acquire all, or part of, 4,520,000 Optioned Shares at a price of \$0.05 per Optioned Share. In addition, Mr. Isenor owns 1,380,000 common shares (“**Common Shares**”) of the Issuer, 1,200,000 Common Share purchase warrants (“**Warrants**”) of the Issuer and options (“**Options**”) to purchase 300,000 Common Shares, and assuming the exercise in full of the Warrants, Options and Optioned Shares held by Mr. Isenor, he would own an aggregate of 7,400,000 Common Shares, representing

approximately 13.59% of the Issuer's then outstanding Common Shares, on a partially diluted basis.

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file the report.

Prior to entering into the Option Agreements, Mr. Isenor owned 1,380,000 Common Shares, 1,200,000 Warrants and Options to purchase 300,000 Common Shares.

Following entering into the Option Agreements, Mr. Isenor has to the option to acquire all, or part of, the Optioned Shares. If Mr. Isenor were to exercise all of his Warrants, Options and has the option to acquire the Optioned Shares, he would own 7,400,000 Common Shares, representing approximately 13.59% of the Issuer's then outstanding Common Shares, on a partially diluted basis.

No consideration was paid in connection with entering into the Option Agreements. In order for Mr. Isenor to exercise the option granted pursuant to the Option Agreements and acquire all, or part of, the Optioned Shares, he must pay the exercise price of \$0.05 per Optioned Share.

The option to purchase the Optioned Shares was granted pursuant to the Option Agreements.

Mr. Isenor entered into the Option Agreements granting him the option to purchase the Optioned Shares for investment purposes. Mr. Isenor may, depending on market and other conditions, increase or decrease its beneficial ownership, control or direction over the Common Shares or other securities of the Issuer, through market transactions, private agreements, treasury issuances, exercise of convertible securities or otherwise. Mr. Isenor currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (j), above.

Mr. Isenor entered into the Option Agreements with each of Irwin Lowy LLP, Irwin Professional Corporation, entities controlled by Chris Irwin, a director of the Issuer, Rustle Woods Capital Inc., an entity controlled by Mark McMurdie, the Chief Financial Officer of the Issuer, David Mosher, Donald Whalen and David Clancy. The Optioned Shares are held by Irwin Lowy LLP as escrow agent pursuant to an escrow agreement.
