The Acquiror is a corporation incorporated under the laws of the Province of British Columbia. The principal business of the Acquiror is the exploration and production of crude oil and natural gas, with operations focused in South America.

- 2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

As disclosed in a press release of the Issuer and the Acquiror dated September 25, 2019, the Acquiror elected to convert the principal amount outstanding of US\$8,800,000 (or approximately CDN\$11,677,600) under its bridge loan facility due September 30, 2019 (“**Bridge Loan**”) to Common Shares at a price of US\$0.22 per Common Share (being the US dollar equivalent of CDN\$0.29, which was the closing price of the Common Shares prior to the December 4, 2018 announcement of the amendment to the Bridge Loan).

As a result of the conversion of the Bridge Loan, the Acquiror will acquire an additional 40,000,000 Common Shares (representing approximately 17.23% of the issued and outstanding Common Shares on a non-diluted basis) (the “**Acquisition**”).

The Acquisition increased the Acquiror's holdings of the issued and outstanding Common Shares from approximately 67.78% and 73.95% on a non-diluted and partially-diluted basis, respectively, to approximately 72.51% and 73.95% on a non-diluted and partially-diluted basis, respectively.

Immediately prior to the Acquisition, the Acquiror beneficially owned and/or exercised control or direction over 157,383,129 Common Shares (representing approximately 67.78% of the issued and outstanding Common Shares on a non-diluted basis), and 212,392,155 Common Shares, assuming the conversion of the Bridge Loan and 15,009,026 common share purchase warrants (the "**Warrants**") held by the Acquiror (representing approximately 73.95% of the issued and outstanding Common Shares on a partially-diluted basis).

Immediately after the Acquisition, the Acquiror beneficially owns and/or exercises control or direction over 197,383,129 Common Shares (representing approximately 72.51% of the issued and outstanding Common Shares on a non-diluted basis), and 212,392,155 Common Shares, assuming the exercise of the Warrants (representing approximately 73.95% of the issued and outstanding Common Shares on a partially-diluted basis). The Acquiror's holdings of Common Shares did not increase on a partially-diluted basis as a result of the Acquisition.
