On December 12, 2024 the manager purchased 20,230 Shares, resulting in a holding of 21,178,668 Shares of the Issuer across its investment strategies, representing approximately 10.01% of the Shares outstanding.

Old West Investment Management, LLC acquired 20,300 shares on December 12, 2024 going over the 10% threshold.

Immediately prior to December 12, 2024 the Old West Investment Management, LLC exercised control or direction over 21,158,438 Shares of the Issuer, representing approximately 9.99% of the outstanding Shares of the Issuer. After the transactions described in this report, the Fund exercised control or direction over 21,178,668 Shares of the Issuer, representing approximately 10.01% of the outstanding Shares of the Issuer.
