Management Discussion of Fund Performance

June 3, 2022

This Management Discussion of Fund Performance presents the views of Counsel Portfolio Services Inc. ("Counsel") on the significant factors and developments during the year ended March 31, 2022 that have affected the Fund's performance and outlook. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report.

In addition, net asset value (NAV) refers to the value of the Fund or a series, as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund seeks a high level of income with the potential for long-term growth by either directly or through securities of other mutual funds, primarily in Canadian and U.S. fixed-income securities, as well as mortgage backed securities, equity and equity-like securities that are expected to produce income.

Risk

The overall level of risk of investing in the Fund remains as discussed in the Fund's initial Simplified Prospectus. The Fund is suitable for investors who: seek North American fixed income investments to hold as part of their portfolio; want a short to medium-term investment; can handle the volatility of bond markets; and have a low to medium tolerance for risk. The Fund is only available on a prospectus-exempt basis and is not available to registered investors.

Results of Operations

Investment Performance

The performance of the Fund's Series O securities is discussed below. The performance of all other series offered by the Fund is shown in the *Past Performance* section of this report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Series Information* section of this report for the varying management and administration fees payable by series.

During the year, the Fund's Series O securities returned 1.50%. This compares with a -0.91% return of the mandate-specific index Bank of America Merrill Lynch High Yield Total Return Index and a -4.52% return of the FTSE Canada

Bond Universe Total Return. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses, and commissions, none of which are reflected in the index returns.

Extremely narrow high-yield spreads (the difference in yield between government bonds and high-yield bonds of similar maturities) in the first half of the period were supported by higher economic growth projections and improving credit fundamentals. However, volatility intensified and spreads widened in the second half, driven by weaker growth prospects as a result of new COVID-19 variants, a downturn in the Chinese property sector, aggressive central bank policies and more cautious investor sentiment in response to escalating geopolitical tensions.

The Fund outperformed the broad-based FTSE Canada Bond Universe Total Return Index. The broad-based index is comprised of Canadian fixed-income securities and has no exposure to high-yield fixed income, whereas the Fund invests in both Canadian and U.S. high-yield fixed-income securities which outperformed investment grade securities in the period. Given the Fund's composition, the mandate-specific index provides a more meaningful comparison.

The Fund outperformed the mandate-specific index primarily due to being overweight to and security selection within the Energy industry.

During the year, the U.S. dollar ("USD") depreciated 0.52% against the Canadian dollar ("CAD"). The Fund's target hedge against the USD varied from 0% to 50% hedge during the period and contributed positively relative to the unhedged indices.

Net Assets

The Fund's NAV declined by \$1.3 million, or 1.2%, to \$105.9 million as at March 31, 2022, from \$107.2 million at March 31, 2021. Of this decrease, \$3.1 million was attributable to net redemptions and partially offset by a \$1.8 million increase due to investment performance.

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the year ended March 31, 2022, was generally similar to the MER for the year ended March 31, 2021. Please note that no management fees are charged to the Fund; see the *Series Information* section of this report for further details. The MERs for all series (before and after waivers or absorptions, if any) are presented in the *Financial Highlights* section of this report.

Recent Developments

Ongoing uncertainty regarding the duration and long-term impact of the COVID-19 pandemic and the effectiveness of vaccines against new variants of the virus contributes to uncertainty regarding the timing of a full economic recovery. As a result, it is not possible to reliably estimate the impact of the pandemic on the financial results and condition of the Fund in future periods.

The sub-advisor notes that it continues to have a moderately positive outlook for the high yield market somewhat due to macroeconomic concerns including geopolitical tensions, central bank hiking cycles, inflationary pressures, and potentially negative effects on energy supplies. The sub-advisor's positive outlook on fundamentals is underpinned by the ongoing distribution of the COVID vaccine, however they remain focused on the health of balance sheets and liquidity metrics, as well as downgrade/default risk. The U.S. high yield default rate (including distressed exchanges) ended March 2022 at 0.50%, well below historical averages. New issuance in March 2022 saw the lightest volumes since March 2020 for a second consecutive month but was met with continued outflows from the asset class. There has been volatility in credit spreads as markets react to the developments of U.S. interest rate hikes and geopolitical concerns; however, on a relative basis, spreads are still below historical averages.

Effective September 22, 2021, Atul Tiwari was appointed to the Counsel Funds' Independent Review Committee.

Effective April 14, 2022, Counsel eliminated its period-end 25% hedge against the USD; the sub-advisor continues to each maintain certain forward positions. Currency hedging is dynamic and may vary between 0-100% at our discretion based on Counsel and the sub-advisor's assessment of currency market conditions.

Related Party Transactions

Management and Administration Services

Top Funds represent nearly all of the Fund's investors. As a result, Counsel pays all costs and expenses (other than certain specified fund costs) required to operate the Fund. No management or administration fees are paid by the Fund.

Other Related Party Transactions

Other investment funds managed by Counsel ("Top Funds") invest in Series O securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. As a result of these investments, the Fund is subject to large transaction risk as discussed in the Counsel Funds' Simplified Prospectus. Counsel manages this risk to reduce the possibility of any adverse effect on the Fund or on its investors, through such processes as requiring advance notice of large redemptions. At March 31, 2022, Top Funds owned nearly 100% of the Fund's NAV. As of March 31, 2022, Counsel had not received any additional notice of large redemptions. All related party transactions are based on the NAV per security on each transaction day.

During the year, the Fund did not rely on an approval, positive recommendation, or standing instruction from the Counsel Funds' Independent Review Committee ("IRC") with respect to any related party transactions.

Management Fees

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by the Manager to pay for: costs of managing the investment portfolio; providing investment analysis and recommendations; making investment decisions; the purchase and sale of the investment portfolio; and providing other services. The Manager also used the management fees to fund trailing commissions and other compensation (collectively, "Distribution Related Payments") paid to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with Counsel may be entitled to Distribution Related payments from Counsel on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., IPC Investment Corporation and Investors Group Financial Services Inc.

Past Performance

The indicated rates of return are the historical annual compound total returns, including changes in NAV per security and assuming reinvestment of all distributions. They do not take into account sales, redemption, distribution or optional sales charges, management fees directly payable by investors or income taxes payable by any investor that would have reduced returns. Returns for each series primarily differ because fees and expenses vary for each series. Please refer to *Series Information* for further information. The past performance of the Fund is not necessarily an indication of how it will perform in the future.


If you hold this Fund outside of a registered plan, income and capital gains distributions paid to you increase your income for tax purposes, whether paid in cash or reinvested in additional securities. Year-by-Year Returns


The bar charts show how much an investment made on the first day of each financial year would have increased or decreased by the end of the respective periods. For the first year of a series, the percentage

The higher PTR in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high PTR and the performance of the Fund. Costs incurred to realign the Fund's portfolio after a fund merger, if any, are excluded from the PTR.
