The Issuer’s issued and outstanding share capital increased in August 2025. As a result of the foregoing, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 27.5%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, Kevin and Linda Smith Living Trust dtd 7/21/1998, and Kevin and Linda Smith Charitable Trust UAD 08/07/2023 (the “**Joint Actors**”) may be considered joint actors.

Due to an increase in the Issuer’s issued and outstanding share capital, slightly offset by a net increase in Crescat’s holdings of 3,157,304 common shares of the Issuer (“**Common Shares**”) and a decrease of 449,998 Common Share purchase warrants of the Issuer (“**Warrants**”), there has been a decrease of approximately 2.93% in Crescat’s securityholding percentage on a partially diluted basis.

As at August 31, 2025, Crescat exercised control over 15,222,986 Common Shares, representing approximately 16.95% of the outstanding Common Shares, and 6,106,814 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 21,329,800 Common Shares representing approximately 22.23% of the issued Common Shares on a partially diluted basis as at August 31, 2025.

As at August 31, 2025, Crescat and the Joint Actors collectively exercised ownership and control over a total of 17,312,741 Common Shares representing approximately 19.27% of the outstanding Common Shares and 8,129,541 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 25,442,282 Common Shares representing approximately 25.97% of the outstanding Common Shares on a partially diluted basis as at August 31, 2025.
