The Shares were acquired by Dundee Corporation (TSX:DC.A) ("Dundee") through its wholly owned subsidiary, Dundee Resources Limited ("DRL"). The Finder's Warrants were acquired by Dundee's wholly owned subsidiary, Goodman & Company, Investment Counsel Inc. ("GCIC").

The Shares and the Finder's Warrants were acquired on November 28, 2018.

DRL and GCIC and, for greater certainty, an employee of an affiliate of Dundee is deemed to be acting jointly and in concert with Dundee in connection with the acquisition of securities to which this report relates.

Dundee acquired 6,000,000 Shares of the Issuer at the price of \$0.25 each for aggregate consideration of \$1,500,000. Additionally, GCIC acquired 366,000 Finder's Warrants, each exercisable into one Share of the Issuer at a price of \$0.25 for a term of 24 months.

Dundee acquired ownership of the securities that triggered the requirement to file this report.

Immediately prior to the acquisition of securities described in this news release, Dundee and its affiliates owned or controlled 1,394,999 Shares and warrants exercisable for the issuance of 249,999 Shares representing an approximate 4.44% interest in the Issuer on an undiluted basis and 5.20% interest in the Issuer on a partially diluted basis.

Immediately following the transaction that triggered the requirement to file this news release, Dundee and its affiliates own or control an aggregate of 7,394,999 Shares and warrants exercisable for the issuance of 615,999 Shares representing an approximate 19.03% interest on an undiluted basis and a 20.29% interest on a partially diluted basis.

Dundee and its affiliates own or control an aggregate of 7,394,999 Shares and warrants exercisable for the issuance of 615,999 Shares representing an approximate 19.03% interest on an undiluted basis and a 20.29% interest on a partially diluted basis.

For greater certainty, a certain individual employed by an affiliate of Dundee concurrently acquired 100,000 Shares representing an approximate 0.44% interest in the Issuer on an undiluted basis and such individual is treated as acting jointly and in concert with Dundee in connection with the acquisition of securities to which this report relates.

DRL acquired 6,000,000 Shares at a price of \$0.25 per Share for total consideration of \$1,500,000. Dundee's affiliate, GCIC, acquired 366,000 Finder's Warrants.

Based upon these and other factors, Dundee may decide to purchase additional securities of the Issuer or may decide in the future to sell all or part of its investment.
