The transaction that triggered the requirement to file this report was the acquisition of Shares as part of a non-brokered private placement, pursuant to which the Issuer issued 11,327,420 charitable flow-through shares of the Company (“**Charity FT Shares**”), at a price of \$2.14 per Charity FT Share for gross proceeds of \$24,240,678.80, which closed on December 3, 2025 (the “**Private Placement**”).

The Acquiror purchased 3,225,806 Shares as a back-end buyer of the Charity FT Shares on December 3, 2025, as part of the Private Placement.

Upon completion of the Private Placement, the Acquiror owns and exercises direction or control over a total of 10,203,888 Shares, representing approximately 13.51% of the issued and outstanding Shares on a non-diluted basis.
