**NOTICE OF ANNUAL GENERAL MEETING OF SHAREHOLDERS**

Accompanying this Notice are an Information Circular, a form of Proxy or Voting Instruction Form ("*VIF*") and a Financial Statement Request Form. The accompanying Information Circular provides information relating to the matters to be addressed at the Meeting and is incorporated into this Notice.

A shareholder entitled to attend and vote at the Meeting is entitled to appoint a proxyholder to attend and vote in his stead. If you are unable to attend the Meeting or any adjournment thereof in person, please read the notes (the "*Notes*") accompanying the form of Proxy enclosed herewith and then complete and return the Proxy within the time set out in the Notes. The enclosed form of Proxy is solicited by Management but, as set out in the Notes, you may amend it if you so desire by striking out the names listed therein and inserting in the space provided the name of the person you wish to represent you at the Meeting. Please advise the Company of any change in your address.

### INFORMATION CIRCULAR

(Containing information as at October 19, 2018, except as indicated)

#### GENERAL PROXY INFORMATION

##### Solicitation of Proxies

This information circular (the "*Information Circular*") is furnished in connection with the solicitation of proxies (each a "*Proxy*") by the management ("*Management*") of Labrador Gold Corp. (the "*Company*") for use at the 2018 Annual General Meeting (the "*Meeting*") of shareholders of the Company ("*Shareholders*") to be held at the time and place and for the purposes set out in the Notice of Meeting distributed with this Information Circular. No director of the Company has informed Management that he intends to oppose any action intended to be taken by Management at the Meeting.

The solicitation of Proxies will be primarily by mail, but Proxies may be solicited personally or by telephone by directors, officers and regular employees of the Company at nominal cost. In accordance with National Instrument 54-101 of the Canadian Securities Administrators ("*National Instrument 54-101*"), arrangements have been made with brokerage houses and other intermediaries, clearing agencies, custodians, nominees and fiduciaries to forward solicitation materials to the beneficial owners of the common shares in the authorized share structure of the Company (the "*Shares*") held of record by such persons and the Company may reimburse such persons for reasonable fees and disbursements incurred by them in so doing. All costs of this solicitation will be borne by the Company.

##### Appointment of Proxyholders

A Shareholder entitled to vote at the Meeting may by means of a Proxy appoint a proxyholder or one or more alternate proxyholders, who need not be Shareholders, to attend and act at the Meeting for the Shareholder on the Shareholder's behalf.

The individuals named in the accompanying form of Proxy are directors and/or officers of the Company. **A Shareholder wishing to appoint some other person (who need not be a Shareholder) to represent the Shareholder at the Meeting has the right to do so, either by striking out the names of Management's nominees and inserting such person's name in the blank space provided in the form of Proxy or by completing another form of Proxy.** Such Shareholder should notify the nominee of his or her appointment, obtain his or her consent to act as proxy and instruct him or her on how the Shareholder's Shares are to be voted. In any case, the form of Proxy should be dated and executed by the Shareholder or the Shareholder's attorney authorized in writing, or if the Shareholder is a corporation, under its corporate seal, or by an officer or attorney thereof duly authorized.

**A Proxy will not be valid for the Meeting or any adjournment thereof unless the completed form of Proxy is delivered, by mail, by hand or by fax, to Computershare Trust Company of Canada, Proxy Department, 100 University Avenue, 8<sup>th</sup> Floor, Toronto, Ontario, M5J 2Y1 Fax number: (within North America) 1-866-249-7775 (outside North America) 416-263-9524, not later than 48 hours (excluding Saturdays, Sundays and holidays) before the commencement of the Meeting or the adjournment thereof at which the Proxy is to be used. A Shareholder may also follow the instructions on the form of proxy to vote by telephone or internet.**

##### Revocability of Proxies

In addition to revocation in any other manner permitted by law, a Shareholder who has given a Proxy may revoke it by either executing a Proxy bearing a later date or by executing a valid notice of revocation, either of the foregoing to be executed by the Shareholder or the Shareholder's authorized attorney in writing; or, if the Shareholder is a company, under its corporate seal by an officer or attorney duly authorized; and by depositing the Proxy bearing a later date with Computershare Trust Company of Canada, Proxy Department, 100 University Avenue, 8<sup>th</sup> Floor, Toronto, Ontario, M5J 2Y1, at any time up to and including the last business day that precedes the day of the Meeting or, if the Meeting is adjourned, that precedes any reconvening thereof, or to the chair of the Meeting on the day of the Meeting or any reconvening thereof, or in any other manner provided by law. In addition, a Proxy may be revoked by the Shareholder personally attending the Meeting and voting the Shareholder's Shares. A revocation of a Proxy will not affect a matter on which a vote is taken before the revocation.

### **Exercise of discretion**

On a poll, the nominees named in the accompanying form of Proxy will vote or withhold from voting the Shares represented thereby in accordance with the instructions of the Shareholder on any ballot that may be called for. If a Shareholder specifies a choice with respect to any matter to be acted upon, such Shareholder's Shares will be voted accordingly. **The Proxy will confer discretionary authority on the nominees named therein with respect to each matter or group of matters identified therein for which a choice is not specified other than the appointment of an auditor and the election of Directors, any amendment to or variation of any matter identified therein and any other matter that properly comes before the Meeting.**

**In respect of a matter for which a choice is not specified or where both choices have been specified in the Proxy, the nominees named in the accompanying form of Proxy will vote Shares represented by the Proxy at their own discretion for the approval of such matter.**

As of the date of this Information Circular, Management Company knows of no amendment, variation or other matter that may come before the Meeting, but if any amendment, variation or other matter properly comes before the Meeting each nominee in the accompanying form of Proxy intends to vote thereon in accordance with the nominee's best judgment.

### **Proxy Voting Options**

Shareholders may wish to vote by Proxy whether or not they are able to attend the Meeting in person. Submitting a Proxy by mail, internet voting or by hand delivery are the only methods by which a Shareholder may appoint a person as Proxy other than a director or officer of the Company named on the form of Proxy.

Registered Shareholders electing to submit a Proxy must complete, date and sign the form of Proxy. It must then be delivered by mail or by hand to the Company's transfer agent, Computershare Trust Company of Canada, Proxy Department, 8th Floor, 100 University Avenue, Toronto, Ontario, M5J 2Y1, not later than 48 hours (excluding Saturdays, Sundays and holidays) before the commencement of the Meeting or the adjournment thereof. A Shareholder may also follow the instructions on the form of proxy to vote by telephone or internet.

### **Advice to Beneficial Shareholders**

The information set forth in this section is of significant importance to many Shareholders of the Company, as a substantial number of Shareholders do not hold Shares in their own name. Shareholders who do not hold their Shares in their own name (referred to in this Information Circular, collectively, as "*Beneficial Shareholders*") should note that only Proxies deposited by Shareholders whose names appear on the records of the Company as the registered holders of Shares can be recognized and acted upon at the Meeting. If Shares are listed in an account statement provided to a Shareholder by a broker, then in almost all cases those Shares will not be registered in the Shareholder's name on the records of the Company. Such Shares will more likely be registered under the names of the Shareholder's broker or an agent of that broker. In the United States the vast majority of such shares are registered under the name of Cede & Co. as nominee for The Depository Trust Company (which acts as depository for many U.S. brokerage firms and custodian banks), and in Canada under the name of CDS & Co. (the registration name for The Canadian Depository for Securities Limited; and which acts as nominee for many Canadian brokerage firms). **Beneficial Shareholders should ensure that instructions respecting the voting of their Shares are communicated to the appropriate person.**

Applicable regulatory policy requires intermediaries/brokers to seek voting instructions from Beneficial Shareholders in advance of shareholders' meetings. Every intermediary/broker has its own mailing procedures and provides its own return instructions to clients, which should be carefully followed by Beneficial Shareholders in order to ensure that their Shares are voted at the Meeting. The form of proxy supplied to a Beneficial Shareholder by its broker (or the agent of the broker) is similar to the form of Proxy provided to registered Shareholders by the Company. However, its purpose is limited to instructing the registered Shareholder (the broker or agent of the broker) how to vote on behalf of the Beneficial Shareholder. The majority of brokers now delegate responsibility for obtaining instructions from clients to Broadridge Financial Solutions Inc. ("*Broadridge*") in the United States and in Canada. Broadridge typically applies a special sticker to proxy forms, mails those forms to the Beneficial Shareholders and requests the Beneficial Shareholders to return the proxy forms to Broadridge. Broadridge then tabulates the results of all instructions received and provides appropriate instructions respecting the voting of Shares to be represented at the Meeting. **A Beneficial Shareholder receiving a Broadridge proxy cannot use that proxy to vote Shares directly at the Meeting. That proxy must be returned to Broadridge well in advance of the Meeting in order to have the Shares voted.**

Although a Beneficial Shareholder may not be recognized directly at the Meeting for the purposes of voting Shares registered in the name of his or her broker (or agent of the broker), a Beneficial Shareholder may attend at the Meeting as proxyholder for the registered Shareholder and vote the Shares in that capacity. Beneficial Shareholders who wish to attend at the Meeting and indirectly vote their Shares as proxyholder for the registered Shareholder should enter their own names in the blank space on the instrument of proxy provided to them and return the same to their broker (or the broker's agent) in accordance with the instructions provided by such broker (or agent), well in advance of the Meeting. Alternatively, a Beneficial Shareholder may request in writing that his or her broker send to the Beneficial Shareholder a legal Proxy which would enable the Beneficial Shareholder to attend at the Meeting and vote his or her Shares.

The Company is not sending its proxy-related materials to the registered Shareholders or Beneficial Shareholders using “notice and access”, as defined in National Instrument 54-101.

The Company does not intend to pay for intermediaries to distribute the proxy-related materials for the Meeting to Beneficial Shareholders who are “objecting beneficial owners”.

### **INTEREST OF CERTAIN PERSONS IN MATTERS TO BE ACTED UPON**

The directors and officers of the Company are eligible for grants of options under the Company’s Stock Option Plan and therefore have an interest in the approval of the Company’s Stock Option Plan. Except as set out herein, none of the directors or executive officers of the Company, nor any person who has held such a position since the beginning of the last completed financial year end of the Company, nor any proposed nominee for election as a director of the Company, nor any associate or affiliate of the foregoing persons, has any material interest, direct or indirect, by way of beneficial ownership of securities or otherwise, in any matter to be acted on at the Meeting other than the election of directors or the appointment of auditors.

### **Record Date and Voting Securities**

The Company has set the close of business on October 19, 2018 as the record date (the “*Record Date*”) for determination of persons entitled to receive notice of the Meeting. Only the registered holders of Shares, and those Beneficial Shareholders entitled to receive notice pursuant to National Instrument 54-101 through their intermediaries, as at that date, are entitled to receive notice of and to vote at the Meeting.

### **PRINCIPAL SHAREHOLDERS AND PERSONS SOLICITING PROXIES**

The Company is authorized to issue an unlimited number of Shares, each carrying the right to one vote, of which 51,592,552 Shares are issued and outstanding as at the date hereof. The Company has no other class of voting securities and no group of shareholders has the right to elect a specified number of directors. There are no cumulative or similar voting rights attached to the Shares.

**On a show of hands, every individual who is present and is entitled to vote as a Shareholder or as a representative of one or more corporate shareholders will have one vote, and on a poll every shareholder present in person or represented by a proxy and every person who is a representative of one or more corporate shareholders, will have one vote for each Share registered in that shareholder’s name on the list of shareholders as at the Record Date, which is available for inspection during normal business hours at Computershare Investor Services Inc. and will be available at the Meeting. Shareholders represented by proxy holders are not entitled to vote on a show of hands.**

To the knowledge of the directors and executive officers of the Company, only the following Shareholder beneficially owns Shares carrying 10% or more of the voting rights attached to any class of voting securities of the Company:

### **ELECTION OF DIRECTORS**

The directors of the Company are elected annually and hold office until the next annual general meeting of the Shareholders or until their successors in office are duly elected or appointed. The term of office of each member of the Board of Directors expires at the Meeting.

Shareholder approval will be sought to fix the number of directors of the Company at four (4).

The persons named below will be presented for election at the Meeting as Management’s nominees and the persons proposed by Management as proxyholders in the accompanying form of proxy intend to vote for the election of these nominees. Management does not contemplate that any of these nominees will be unable to serve as a director. Each director elected will hold office until the next annual general meeting of the Company or until his successor is elected or appointed, unless his office is earlier vacated in accordance with the Articles of the Company or the provisions of the *Business Corporations Act* (British Columbia).

The following table sets out the names of Management's nominees for election as a director (a "proposed director"), the province or state, as applicable, and country of residence, their principal occupations, the date each first became a director of the Company, and the number of Shares beneficially owned by each, directly or indirectly, or over which control or direction is exercised, as at the date hereof. The table also sets out the members of the Company's Audit Committee. Management does not contemplate that any of these nominees will be unable to serve as a director.

Mr. Borland was a director of Acadian Mining Corporation ("*Acadian*") in December 2008 when ScoZinc Limited ("*ScoZinc*"), a wholly owned subsidiary of Acadian, was granted an order by the Supreme Court of Nova Scotia under the *Companies Creditors' Arrangement Act* protecting it from its creditors. The creditors of ScoZinc accepted the plan of arrangement ("Plan of Arrangement") ScoZinc presented to them at a meeting held on May 21, 2009, and the Plan of Arrangement was ratified by the Nova Scotia Supreme Court on May 29, 2009. The Plan of Arrangement was implemented and all affected creditors were paid in accordance with the terms of the Plan of Arrangement. The implementation of the Plan of Arrangement has been discharged.

### Stock Option Plans and Other Incentive Plans

The Board of Directors of the Company has previously adopted the Company's stock option plan effective January 23, 2006, as amended (the "*Plan*"), which is a "rolling" stock option plan pursuant to which a maximum of 10% of the issued and outstanding Shares are reserved for issuance upon the exercise of incentive stock options ("*Options*").

The purpose of the Plan is to allow the Company to grant Options to directors, officers, employees and consultants of the Company and its subsidiaries or employees of companies providing management or consulting services to the Company or its subsidiaries (each, an "*Eligible Optionee*") as additional compensation, and as an opportunity to participate in the success of the Company. The granting of such Options is intended to align the interests of such persons with that of the shareholders. Options are exercisable over periods of up to five years as determined by the Board of Directors of the Company and are required to have an exercise price no less than the greater of \$0.10 and the closing market price of the Shares prevailing on the day preceding the day that the Option is granted less a discount of up to 25%, the amount of the discount varying with market price in accordance with the policies of the TSX Venture Exchange (the "*Exchange*").

The Plan contains no vesting requirements, but permits the Board of Directors to specify a vesting schedule in its discretion. The Plan provides that if a change of control, as defined therein, occurs, all Options shall immediately become vested and may thereupon be exercised in whole or in part by the option holder.

In addition, the Plan provides as follows:

- (a) the number of Shares which may be issued to any one individual pursuant to the exercise of options may not exceed 5% of the issued Shares on a yearly basis;
- (b) the number of Shares which may be issued to any one consultant pursuant to the exercise of options may not exceed 2% of the issued Shares on a yearly basis;
- (c) the number of Shares which may be issued, in the aggregate, to a person conducting investor relations activities may not exceed 2% of the issued Shares on a yearly basis. Options issued to Consultants retained to provide investor relations activities must vest in stages over a period of at least 12 months with no more than 1/4 of the options vesting in any three month period; and

- (d) if an optionee ceases to be an Eligible Optionee, any Options held by such Optionee shall expire no later than 90 days from the date such optionee ceases to be an Eligible Optionee (or 30 days if the optionee is engaged in investor relations activities). If an Eligible Optionee ceases to be an optionee due to death, the Options held by such optionee will expire 12 months from the date of death of the Option Holder; or a Consultant, or an Employee performing Investor Relations Activities, the Expiry Date shall be one month from the date of death of the Option Holder.

The Plan was last approved by the Company's shareholders at the Company's last annual general meeting held on October 20, 2017. Exchange policy requires that all such rolling stock option plans be approved by shareholders on an annual basis, and consequently the Company is seeking Shareholder approval of the Plan at the Meeting.

### **Employment, Consulting and Management Agreements and External Management Companies**

Pursuant to a contract made as of the 1st day of January 2018 (the "*Moss Contract*") between the Company and Moss Exploration Services Ltd. ("*Moss*"), a company controlled by Dr. Roger Moss, the Company agreed to pay to Moss a fee of \$8,000 per month plus applicable taxes. The Moss Contract contains termination provisions, which may be summarized as follows:

- (a) Moss may terminate the Moss Contract by giving notice to the Company at least one month prior to termination;
- (b) The Company may terminate the Moss Contract immediately upon the death of Dr. Moss or for cause, upon which Moss is entitled to the prorated portion of its fee through the date of termination and reimbursement for expenses properly incurred prior to the date of termination plus the prorated portion of its fee for an additional period of one month. "Cause" is defined as existing if:
- (i) Moss commits a breach of any of the material provisions contained in the Moss Contract;
  - (ii) Moss is guilty of any misconduct or neglect in the discharge of its duties pursuant to the Moss Contract;
  - (iii) Moss becomes bankrupt or makes any arrangements or assignments with its creditors; or
  - (iv) Moss or Dr. Moss is convicted of any criminal offence or misdemeanor involving moral turpitude.
- (c) The Company may terminate the Moss Contract in any other circumstance on three months' notice to Moss, provided that if Moss is terminated without Cause or voluntarily resigns for "Good Reason" within 90 days following a "Change in Control", the Company is required to pay to Moss an amount equal to twelve months payment of the fee then in effect (the "Control Payment"). "Good Reason" is defined to mean (1) a reduction in the fee, (2) a material reduction in Moss's responsibilities or duties or (3) a requirement that Moss relocate its residence from its present location. The Moss Contract states that a "Change in Control" will be evidenced by the election or appointment of a majority of new directors of the Company or the acquisition by any person or by any person and such person's associates or related bodies corporate, as such terms are defined in the *Securities Act* (British Columbia), and whether directly or indirectly, of shares of the Company which, when added to all other shares of the Company at the time held by such person and such person's associates and related bodies corporate, totals for the first time fifty percent (50%) or more of the outstanding shares of the Company. The Moss Contract further provides that the Company is not required to make the Control Payment to Moss if, after a Change in Control, Moss is offered a reasonably equivalent position with the surviving corporation and does not accept such position.

Delphis Financial Strategies Inc., a company controlled by Ms. Aurora Davidson, CFO of the Company, charges a monthly retainer for accounting services rendered to the Company.

### **Oversight and Description of Named Executive Officer and Director Compensation**

The Company's Named Executive Officer and director compensation is determined by the Board of Directors as a whole (the "*Board*"). The Board evaluates the consulting fees paid to its Named Executive Officers on a regular basis, and, in such evaluation, compares the fees charged the Named Executive Officers against the rates of other consultants that provide similar services. A peer group is not used to determine compensation.

Other than the compensation disclosed above under "Director and Named Executive Officer Compensation, Excluding Compensation Securities" and "Employment, Consulting and Management Agreements and External Management Companies", no additional compensation was paid to the Named Executive Officers during the year ended September 30, 2017. None of such compensation is tied to any performance criteria or goals.

Other than as disclosed below and herein, none of the directors or executive officers of the company, nor any proposed nominee for election as a director of the Company, nor any person who beneficially owns, directly or indirectly, Shares carrying more than 10% of the voting rights attached to all outstanding Shares, nor any associate or affiliate of the foregoing persons, has any material interest, direct or indirect, in any transactions since the commencement of the Company's last completed financial year, or in any proposed transaction which, in either case, has or will materially affect the Company.

During the year ended September 30, 2017, on December 23, 2016 and February 2, 2017 the Company completed a private placement on a non-brokered basis, of an aggregate of 5,630,000 units at a price of \$0.08 per unit. The Company also issued 1,068,334 Shares on a flow-through basis (the "*FT Shares*") priced at \$0.09 per FT Share pursuant to which directors of the Company purchased an aggregate of 170,000 FT Shares, as to Roger Moss purchased 120,000 shares and Trevor Boyd purchased 50,000 shares.

Pursuant to the above private placement, in January, 2017, the Company received a subscription from Plethora for the purchase of 3,125,000 units ("*2017 Units*") at a price of \$0.08 per unit. On February 2, 2017, the Company issued to Plethora 3,125,000 2017 Units at a price of \$0.08 per unit, with each 2017 Unit consisting of one Share and one share purchase warrant, with each warrant (a "*February 2017 Warrant*") entitling it to purchase an additional Share at an exercise price of \$0.13 per Share for a period of two years.

**APPOINTMENT OF AUDITOR**

DeVisser Gray LLP, Chartered Professional Accountants, of Vancouver, British Columbia are the auditors of the Company. Unless otherwise instructed, the proxies given pursuant to this solicitation will be voted for the re-appointment of DeVisser Gray LLP, Chartered Professional Accountants as the auditors of the Company to hold office for the ensuing year at remuneration to be fixed by the Directors.

**MANAGEMENT CONTRACTS**

Except as set out below, there are no management functions of the Company which are, to any substantial degree, performed other than by the Directors or Executive Officers of the Company.

The Company incurred \$15,301 in consulting fees payable to Moss Exploration Services Ltd., a company controlled by Roger Moss, President, CEO and Director of the Company, for business and geological consulting services provided to the Company from October 1, 2016 to September 30, 2017. A formal consulting agreement between the Company and Moss Exploration Services Ltd. was entered into on January 1, 2018.

The Company incurred \$12,000 in consulting fees payable to Delphis Financial Strategies Inc., of Vancouver, British Columbia, a company controlled by Aurora Davidson, Chief Financial Officer and Secretary of the Company, for financial and management consulting services provided to the Company from October 1, 2016 to September 30, 2017. There is no formal consulting agreement between the Company and Delphis Financial Strategies Inc.

## **AUDIT COMMITTEE**

### **Mandate of the Audit Committee**

The primary function of the Audit Committee is to assist the Board in fulfilling its financial oversight responsibilities by reviewing the financial reports and other financial information provided by the Company to regulatory authorities and shareholders, the Company's systems of internal controls regarding finance and accounting and the Company's auditing, accounting and financial reporting processes. The Audit Committee is also responsible for monitoring compliance with applicable laws and regulations and the systems of internal controls. The Audit Committee has the authority to retain special legal, accounting or other consultants to advise the Audit Committee. The Audit Committee may request any director, officer or employee of the Company, or the Company's outside counsel or independent auditor, to attend a meeting of the Audit Committee or to meet with any members of, or consultants to, the Audit Committee. The Board has adopted an Audit Committee Charter, a full copy of which is attached to this information circular as Schedule "A".

### **Operation, composition, appointments, compensation and meetings of the Audit Committee**

The Audit Committee reports to the Board. The full Board is kept informed of the Audit Committee's activities by a report following each Audit Committee meeting.

The Audit Committee consists of not less than three Directors as determined by the Board. The Company's Audit Committee is presently comprised of James S. Borland (Chairman), Trevor Boyd and Leo Karabelas. James S. Borland, Trevor Boyd and Leo Karabelas are independent and are all "financially literate", meaning that they are able to read and understand the Company's financial statements and to understand the breadth and complexity of the issues that can reasonably be expected to be raised by the Company's financial statements. James S. Borland has been involved in the mining industry for more than 25 years. Trevor Boyd is a professional geologist with over 30 years of experience, holds a Ph.D in geology and has worked with both private and public companies. Leo Karabelas has more than 12 years of diverse experience in the mining industry.

Members of the Audit Committee are appointed at a meeting of the Board typically held immediately after the Company's annual shareholders' meeting; provided that any member may be removed or replaced at any time by the Board and shall in any event cease to be a member of the Audit Committee upon ceasing to be a member of the Board. Where a vacancy occurs at any time in the membership of the Audit Committee it may be filled by the Board.

### **Audit Committee oversight**

At no time since the commencement of the Company's most recently completed financial year was a recommendation of the Audit Committee to nominate or compensate an external auditor not adopted by the Board.

### **Reliance on certain exemptions**

At no time since the commencement of the Company's most recently completed financial year has the Company relied on the exemption in Section 2.4 of National Instrument 52-110 ("*NI 52-110*"), or an exemption from NI 52-110, in whole or in part, granted under Part 8 of NI 52-110. Because the Company is a "venture company" as defined in NI 52-110, the Company is relying on the exemption in section 6.1 of NI 52-110 from the requirements of Part 3 (Composition of the Audit Committee) and Part 5 (Reporting Obligations) of NI 52-110.

### **External auditors**

The Audit Committee, in its Audit Committee Charter, has adopted specific policies and procedures for the engagement of non-audit services.

DeVisser Gray LLP, Chartered Professional Accountants, were the external auditors of the Company for the financial year ending September 30, 2017.

## CORPORATE GOVERNANCE DISCLOSURE

### Independence of Members of Board

The Company's Board currently consists of four directors, three of whom are independent based upon the tests for independence set forth in NI 52-110. James S. Borland, Trevor Boyd and Leo Karabelas are independent. Roger Moss is not independent as he is the President and Chief Executive Officer of the Company. Roger Moss chairs the Company's board meetings and James S. Borland is Chairman of the Company's Audit Committee.

### Management Supervision by Board

The size of the Company is such that all the Company's operations are conducted by a small management team, of which the President is also represented on the Board. The Board considers that management is effectively supervised by the directors on an informal basis as the non-management directors are actively and regularly involved in reviewing and supervising the operations of the Company and have regular and full access to management.

### Participation of Directors in Other Reporting Issuers

The participation of the directors in other reporting issuers is described in the table provided under "Election of Directors" in this Information Circular.

### Orientation and Continuing Education

While the Company does not have formal orientation and training programs, new Board members are provided with:

1. information respecting the functioning of the Board of Directors, committees and copies of the Company's corporate governance policies;
2. access to recent, publicly filed documents of the Company; and
3. access to Management.

Board members are encouraged to communicate with Management, auditors and technical consultants; to keep themselves current with industry trends and developments and changes in legislation with Management's assistance; and to attend related industry seminars and visit the Company's operations. Board members have full access to the Company's records.

### Ethical Business Conduct

The Board views good corporate governance as an integral component to the success of the Company and to meet responsibilities to shareholders. The Board and Management work together to ensure that the Company's operations are carried out in an open and ethical manner.

## **Nomination of Directors**

The Board has responsibility for identifying potential Board candidates. The Board assesses potential Board candidates to fill perceived needs on the Board for required skills, expertise, independence and other factors. Members of the Board and representatives of the mining industry are consulted for possible candidates.

## **Compensation of Directors and Named Executive Officers**

Compensation is paid to the company of the CEO based on a monthly retainer. The CFO's management company is paid a monthly retainer which is currently less than 50% of the amount originally agreed to by the parties at the time the CFO joined the Company. No fees are paid to the non-management directors for acting as directors.

## **Board Committees**

The Company has no committees other than the Audit Committee.

As the directors are actively involved in the operations of the Company and the size of the Company's operations does not warrant a larger board of directors, the Board has determined that additional committees are not necessary at this stage of the Company's development.

## **Assessments**

The Board does not consider that formal assessments would be useful at this stage of the Company's development.

## **PARTICULARS OF MATTERS TO BE ACTED UPON**

### **Approval and Ratification of Rolling 10% Stock Option Plan**

The Board of Directors of the Company implemented the Plan effective January 23, 2006, and the Plan was amended by the Board of Directors effective July 15, 2011. The Plan was approved by the Exchange and was last approved by Shareholders at the Company's 2017 annual general meeting, and there have been no changes to the Plan since those approvals were obtained.

Please refer to "Stock Option Plans and Other Incentive Plans" for particulars in respect of the Plan.

At the Meeting, Shareholders will be asked to pass a resolution in the following form:

"RESOLVED that the Company approve and ratify, subject to regulatory approval, the Stock Option Plan, as described in the Company's Information Circular dated October 19, 2018, pursuant to which the directors may, from time to time, authorize the issuance of options to directors, officers, employees and consultants of the Company and its subsidiaries to a maximum of 10% of the issued and outstanding common shares at the time of the grant, with a maximum of 5% of the Company's issued and outstanding common shares being reserved to any one person on a yearly basis."

The full text of the Plan is available for viewing up to the date of the Meeting at the Company's offices at Suite 1260-355 Burrard Street, Vancouver, BC, and will also be available for review at the Meeting. In addition, a copy of the Plan, will be mailed, free of charge, to any holder of Shares who requests a copy, in writing, from the Secretary of the Company. Any such requests should be mailed to the Company, at its head office, to the attention of the Secretary.

Unless such authority is withheld, the persons named in the enclosed Proxy intend to vote in favour of the above resolutions.

The Company will consider and transact such other business as may properly come before the Meeting or any adjournment thereof. Management of the Company knows of no other matters to come before the Meeting other than those referred to in the Notice of Meeting. Should any other matters properly come before the Meeting the Shares represented by the Proxy solicited hereby will be voted on such matters in accordance with the best judgment of the persons voting the Proxy.

**Matters which may properly come before the Meeting shall be any matter not effecting a change in the Articles of the Company or not disposing of all or substantially all of the assets of the Company.**

## SCHEDULE "A"

### **Audit Committee Charter** (Effective January 27, 2005)

#### *A. Audit Committee Purpose*

The Board of Directors of the Corporation has an overall responsibility to oversee the affairs of the Company for the benefit of the shareholders. The Audit Committee is appointed by the Board to assist the Board in fulfilling its oversight responsibilities. The Audit Committee's primary duties and responsibilities are to:

- Ensure the effectiveness of the overall process of identifying and addressing principal business risk and the adequacy of the related disclosure
- Monitor the integrity of the Company's financial reporting process and systems of internal controls regarding finance, accounting and legal compliance
- Monitor the independence and performance of the Company's independent auditors
- Provide an avenue of communications among the independent auditors, management and the Board of Directors
- Encourage adherence to, and continuous improvement of, the Company's policies, procedures and practices at all levels

The Audit Committee has the authority to conduct any investigation appropriate to fulfilling its responsibilities, and it has direct access to the independent auditors as well as to anyone in the organization. The Audit Committee has the ability to retain, at the Company's expense, special legal, accounting, or other consultants or experts it deems necessary in the performance of its duties.

#### *B. Audit Committee Composition and Meetings*

Audit Committee members shall meet the requirements of the TSX-V and NI 52-110. The Audit Committee shall be comprised of three or more directors as determined by the Board, the majority of whom shall be independent non-executive directors, free from any relationship that would interfere with the exercise of his or her independent judgment. All members of the Committee shall have a basic understanding of finance and accounting and be able to read and understand fundamental financial statements, and at least one member of the Committee shall have accounting or related financial expertise.

Audit Committee members shall be appointed by the Board. If the Audit Committee Chair is not designated or present, the members of the Committee may designate a Chair by majority vote of the Committee membership.

The Committee shall meet at least four times annually, or more frequently as circumstances dictate. The Audit Committee Chair shall prepare and/or approve an agenda in advance of each meeting. The Committee should meet privately in executive session at least annually with management, the independent auditors and as a committee to discuss any matters that the Committee or each of these groups believes should be discussed.

#### *C. Audit Committee Responsibilities and Duties - Detail*

##### Review Procedures

1. Gain an understanding of the Company's current areas of greatest financial risk and whether management is managing these effectively.
2. Review the Company's annual audited financial statements and management discussion and analysis prior to filing or distribution. Review should include discussion with management and independent auditors of significant issues regarding accounting principles, practices and judgments.
3. In consultation with management and the independent auditors, consider the integrity of the Company's financial reporting processes and controls. Discuss significant financial risk exposures and the steps management has taken to monitor, control and report such exposures. Review significant findings prepared by the independent auditors together with management's responses.
4. Review with management the Company's quarterly financial results and management discussion and analysis prior to filing or distribution. Discuss any significant changes to the Company's accounting principles and any items required to be communicated by the independent auditors.

##### Independent Auditors

5. The independent auditors are accountable directly to the Audit Committee. The Audit Committee shall review the independence and performance of the auditors and annually recommend to the Board of Directors the appointment of the independent auditors or approve any discharge of auditors when circumstances warrant.
6. Approve the fees and other significant compensation to be paid to the independent auditors, and pre-approve any non-audit services that the auditor may provide.
7. On an annual basis, the Committee should review and discuss with the independent auditors all significant relationships they have with the Company that could impair the auditor's independence.
8. Review the independent auditors audit plan and engagement letter.
9. Prior to releasing the year-end financial results, discuss the results of the audit with the independent auditors.
10. Consider the independent auditors' judgments about the quality and appropriateness of the Company's accounting principles as applied in its financial reporting practices.

##### Other Audit Committee Responsibilities

11. The Chairman of the Committee will review all disclosure documents to be issued by the Company relating to financial matters, including news releases, annual information forms and information circulars.
12. The Committee will establish a procedure for the: (i) confidential, anonymous submission by employees of the Company of concerns regarding questionable accounting or auditing matters, and (ii) receipt, retention and treatment of complaints received by the Company regarding accounting, internal accounting controls or auditing matters.
