As a result of net purchases of common shares of the Issuer (“**Common Shares**”) acquired by Crescat in November 2020, Crescat's holdings in the Issuer have risen above 10%.

As at November 30, 2020, Crescat exercised control over 8,138,569 Common Shares, representing approximately 7.55% of the outstanding Common Shares, and Common Share purchase warrants of the Issuer (“**Warrants**”) to purchase 2,857,143 Common Shares. Assuming that the Warrants are exercised, Crescat will hold 10,995,712 Common Shares representing approximately 9.94% of the outstanding Common Shares on a partially-diluted basis.

Crescat and the Joint Actors collectively exercise control over a total of 8,213,569 Common Shares (representing approximately 7.62% of the outstanding Common Shares) and 2,857,143 Warrants. Assuming the Warrants are exercised, Crescat and the joint actors will collectively exercise control over an aggregate of 11,070,712 Common Shares representing approximately 10.01% of the outstanding Common Shares on a partially-diluted basis.
