On Sept 13, 2021, a total of 6,500,000 Warrants with an exercise price of \$0.07 per common share of the Corporation (“**Share**”) held by 2176423 Ontario (a corporation beneficially owned by Mr. Sprott) were exercised, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 2.8% on a partially diluted basis since the date of the last early warning report.

The exercise of 6,500,000 Warrants (along with intervening treasury issuances by the Corporation) results in a decrease in holdings of approximately 2.8% of the Shares outstanding on a partially diluted basis from what was reported in the last early warning report. See items 2.2 and 3.4.

Prior to the exercise of Warrants, Mr. Sprott beneficially owned and controlled 29,326,482 Shares and 13,628,075 Warrants representing approximately 16.4% of the outstanding Shares on a non-diluted basis and approximately 22.3% on a partially diluted basis assuming the exercise of all such Warrants.

Mr. Sprott now beneficially owns and controls 35,826,482 Shares and 7,128,075 Warrants representing approximately 19.3% of the outstanding Shares on a non-diluted basis and approximately 22.3% on a partially diluted basis assuming the exercise of such Warrants.

The Warrants were exercised for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
