The Issuer’s issued and outstanding share capital increased and as a result, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors have fallen below 10%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

The aggregate number of Common Shares held and the number of Common Shares that may be acquired by Crescat pursuant to the exercise of Warrants has increased by 2,057,754 Common Shares. However, there has been an increase in the Issuer's issued and outstanding share capital. In total, the percentage of Common Shares held or that may be acquired by Crescat has decreased by approximately 1.32%.

As at May 31, 2021, Crescat exercised control over 10,196,323 Common Shares, representing approximately 6.87% of the outstanding Common Shares, and warrants of the Issuer ("Warrants") to purchase 2,857,143 Common Shares. Assuming that the Warrants are exercised, Crescat will hold 13,053,466 Common Shares representing approximately 8.62% of the outstanding Common Shares on a partially-diluted basis.

As at May 31, 2021, Crescat and the Joint Actors collectively exercise control over a total of 10,344,323 Common Shares (representing approximately 6.97% of the outstanding Common Shares) and 2,857,143 Warrants. Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 13,201,466 Common Shares representing

approximately 8.72% of the outstanding Common Shares on a partially diluted basis.
