1. Change in Financial Year-End

Silver Storm Mining Ltd. (formerly, Golden Tag Resources Ltd.) (the “**Issuer**”) has decided to change its year-end from December 31st to March 31st.

The reason for the change is to better align the Reporting Issuer’s financial reporting and tax planning with its business planning.
