The Issuer’s issued and outstanding share capital increased. As a result of the foregoing, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 17.50%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 782,615 Common Shares in Crescat’s holdings; however, on a percentage basis there has been a decrease of approximately 0.85% due to the increase in the Issuer’s issued and outstanding share capital.

As at October 31, 2021, Crescat exercised control over 16,833,717 Common Shares, representing approximately 11.97% of the outstanding Common Shares, and 7,589,545 common share purchase warrants of the Issuer (“**Warrants**”). Assuming that all of the Warrants are exercised, Crescat will hold 24,423,262 Common Shares representing approximately 16.48% of the issued Common Shares on a partially diluted basis as at October 31, 2021.

As at October 31, 2021, Crescat and the Joint Actors collectively exercise ownership and control over a total of 17,393,717 Common Shares (representing approximately 12.37% of the outstanding Common Shares) and 7,764,545 Warrants. Assuming that all of the Warrants are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 25,158,262 Common Shares representing approximately 16.96% of the outstanding Common Shares on a partially diluted basis as at October 31, 2021.
