As a result of the expiration of 1,523,815 Warrants held by Crescat and the Joint Actors (as defined herein) in September, 2022, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors have fallen below 17.50%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net decrease of 10,037,151 Common Shares in Crescat's holdings representing a decrease of approximately 2.04% on a non-diluted basis and, assuming that all of Warrants held by Crescat are exercised, a decrease of approximately 0.34% on a partially diluted basis.

As at September 30, 2022, Crescat exercised control over 8,274,865 Common Shares, representing approximately 14.75% of the outstanding Common Shares, and 1,396,961 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 9,671,826 Common Shares representing approximately 16.82% of the issued Common Shares on a partially diluted basis as at September 30, 2022.

The transaction did not involve a securities lending arrangement.

As at September 30, 2022, Crescat and the Joint Actors collectively exercised ownership and control over a total of 8,444,864 Common Shares (representing approximately 15.05% of the outstanding Common Shares) and 1,396,961 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 9,841,825 Common Shares representing approximately 17.11% of the

outstanding Common Shares on a partially diluted basis as at September 30, 2022.
