The requirement to file this report was triggered by the closing of the Private Placement on July 24, 2025, in which Crescat, an investment manager with discretionary authority operating in the United States, acquired 5,882,354 units of the Issuer (the “**Units**”) at a price of \$0.085 per Unit. Each Unit was comprised of one common share of the Issuer (each, a “**Common Share**”) and one Common Share purchase warrant of the Issuer (each, a “**Warrant**”). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.13 per Common Share for a term of two years.

As a result of the Private Placement, the collective partially diluted holdings in the Issuer of Crescat have risen above 12.5%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, Kevin and Linda Smith Living Trust dtd 7/21/1998, and Kevin and Linda Smith Charitable Trust UAD 08/07/2023 (the “**Joint Actors**”) may be considered joint actors.

Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 16,848,899 Common Shares representing approximately 13.63% of the issued Common Shares on a partially diluted basis as at July 31, 2025.
