On July 7, 2018 and July 18, 2018, a total of 25,000,000 Warrants with an exercise price of \$0.15 per common share of the Corporation (“**Share**”) held by Mr. Sprott expired, resulting in Mr. Sprott’s beneficial ownership of the Corporation decreasing by approximately 10.2% on a partially diluted basis.

The 25,000,000 Warrants that expired in July 2018 represent a decrease in holdings of approximately 10.2% of the Shares outstanding on a partially diluted basis assuming the Warrants had been exercised.

Prior to the expiry of Warrants, Mr. Sprott beneficially owned and controlled 35,333,334 Shares and 33,333,334 Warrants, representing approximately 27.2% of the then outstanding Shares on a non-diluted basis and approximately 42.8% on a partially diluted basis assuming exercise of the Warrants.

Mr. Sprott now beneficially owns and controls 35,333,334 Shares and 10,333,334 Warrants, representing approximately 27.2% of the outstanding Shares on a non-diluted basis and approximately 32.6% on a partially diluted basis assuming exercise of the Warrants.

The Warrants expired unexercised and out of the money. Mr. Sprott has a long-term view of the investment and may acquire additional securities either on the open market or through private acquisitions or sell securities either on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
